Requested Action:

This report is intended to provide the Members with an update on the Enforcement Program at the Medical Board of California (Board). No action is needed at this time.

Expert Reviewer Program:

There are currently 954 active experts in the Board's expert database. 229 experts were utilized to review 413 cases from July 1, 2017 through December 31, 2017 (**Attachment A**). Additional experts are needed in the following specialties:

- Allergy and immunology
- Addiction medicine with added certification in family medicine or internal medicine or psychiatry
- Colon/rectal surgery
- Dermatology
- Family medicine
- Gastroenterology
- Neurological surgery
- Neurology
- Pain medicine
- Pathology (preferably from the following counties: Orange, Riverside, Sacramento, San Bernardino, San Diego, San Francisco, and Ventura)
- Forensic Pathology
- Pediatric cardiac surgery
- Pediatric gastroenterology
- Pediatric pulmonology
- Pediatric surgery
-
- Plastic surgeons with the following expertise: 1) Neograft hair transplant/FUE transplant; 2) gender reassignment surgical procedure
- Psychiatry (forensic and addiction)
- Thoracic surgery (cardiac surgery)
- Urology (and urologists with expertise in gender reassignment surgical procedure)
- Vascular surgery

Expert reviewer training was held on November 2, 2017, in Sylmar, California. Staff is working to secure location sites for training in 2018, which will be held in September and October.

Central Complaint Unit:

The average number of days to initiate a complaint in the Central Complaint Unit (CCU) is eight for the second quarter of FY 2017-2018, which is within the timeframe mandated by Business and Professions Code section 129(b).

CCU analysts continued their efforts to reduce the aging of all case types. While a decrease in the average number of days to process a complaint was not accomplished, it remained steady and is currently at 90 days.

CCU management filled one of the two vacant staff services analyst (SSA) positions mentioned in the previous enforcement summary. The employee reported to work on November 13, 2017. Interviews were conducted for the second vacant SSA position, however, the top candidates accepted offers at other agencies, and therefore the position was re-advertised. In addition to the SSA position that was re-advertised, CCU currently has one vacant staff services manager (SSM I) position following a retirement from state service, one vacant SSA position resulting from a promotion, and one vacant management services technician (MST) position also due to a promotion. All but the SSM I position have been advertised and interviews are expected to take place in January.

Discipline Coordination Unit:

The Discipline Coordination Unit (DCU) filled its SSA position and the candidate began employment in November 2017. Candidates were selected for the vacant MST and limited-term office technician positions. Tentative offers were made, pending hiring clearances.

Complaint Investigation Office:

The Complaint Investigation Office (CIO) non-sworn special investigators (SI) continue to have a case load of approximately 54 cases. Since the last enforcement summary, CIO has closed 50 cases and has transmitted 15 cases to the Attorney General's Office (AGO) – 8 malpractice, 3 criminal conviction cases (to include 1 PC 23 Order), and 4 petitions for reinstatement of licensure. The average number of days for CIO to complete an investigation is 303 days. This increase is a result of a vacant SI position and the reduction of a full-time employee to part-time for another SI.

Interviews to fill the part-time SI position were conducted and a tentative offer was made pending hiring clearances. Interviews to backfill the full-time SI position are anticipated to be conducted in late January.

Probation Unit:

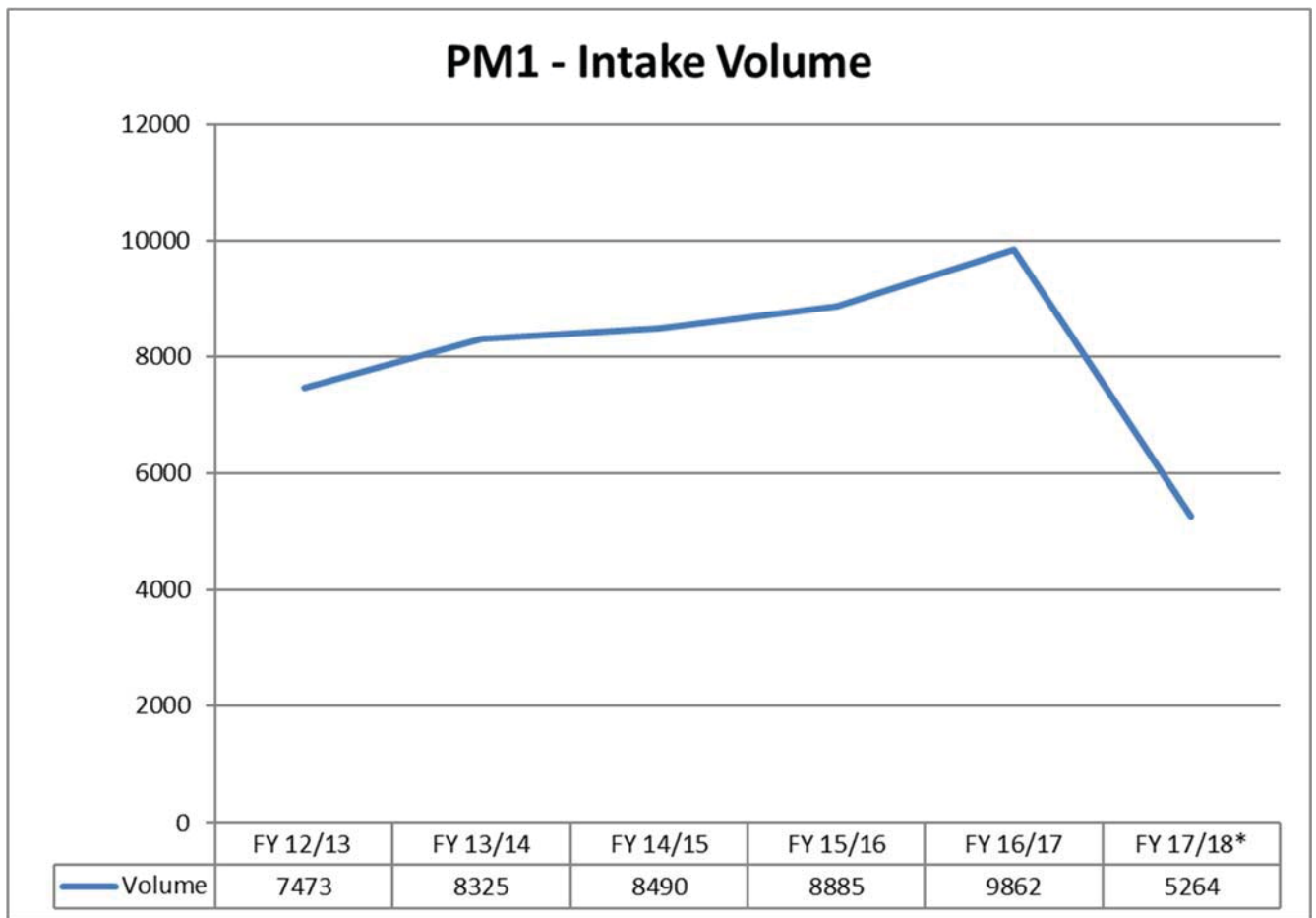
The Probation Unit filled one Inspector III (supervisory) position in the San Dimas field office in June. However, the two Inspector III positions at the Cerritos and Sacramento field offices remain vacant. The Inspector III exam is currently posted and will be closing on January 5, 2018. The list is expected to be finalized by the end of January and then the two positions will be re-advertised. February 2018 is the anticipated date management will conduct interviews for the vacant Inspector III positions.

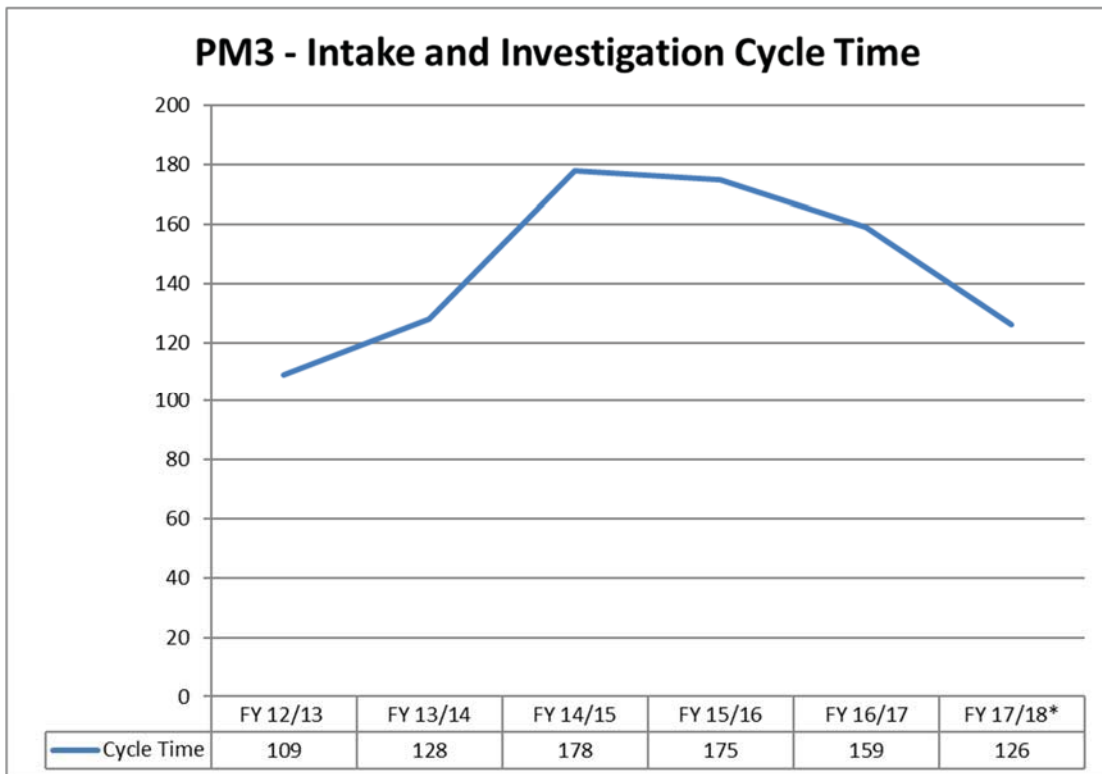
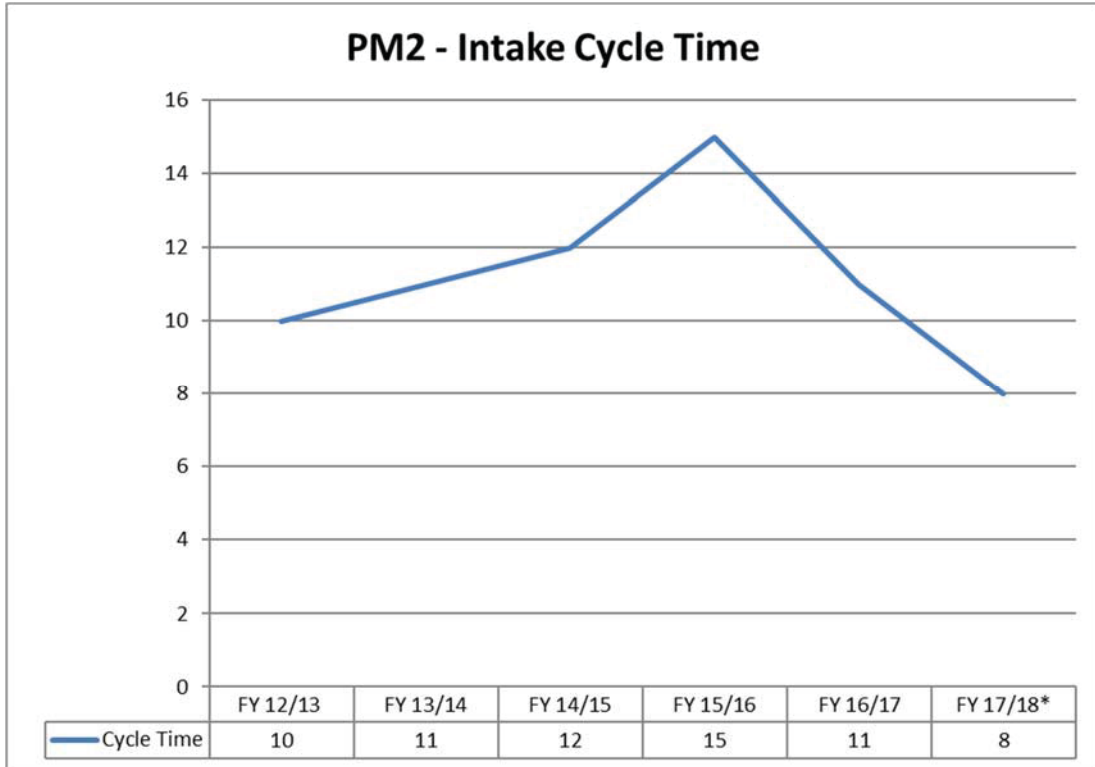
Presently the San Dimas and Cerritos offices are fully staffed with inspector positions.

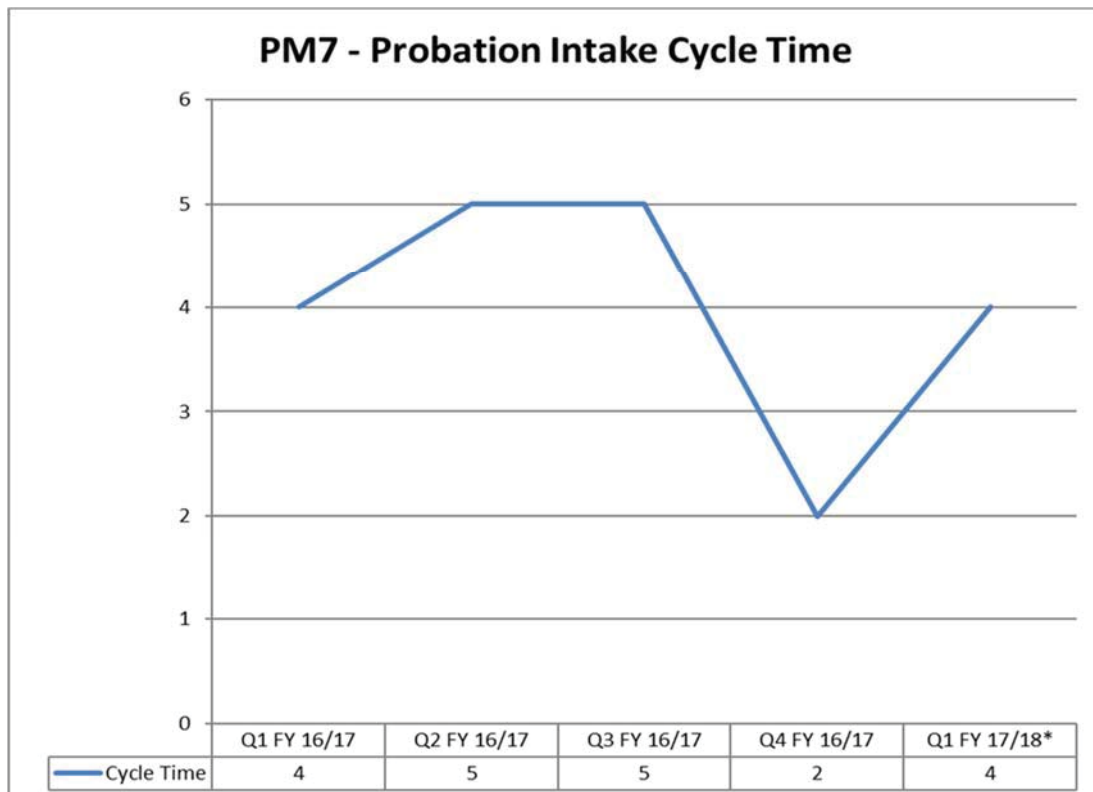
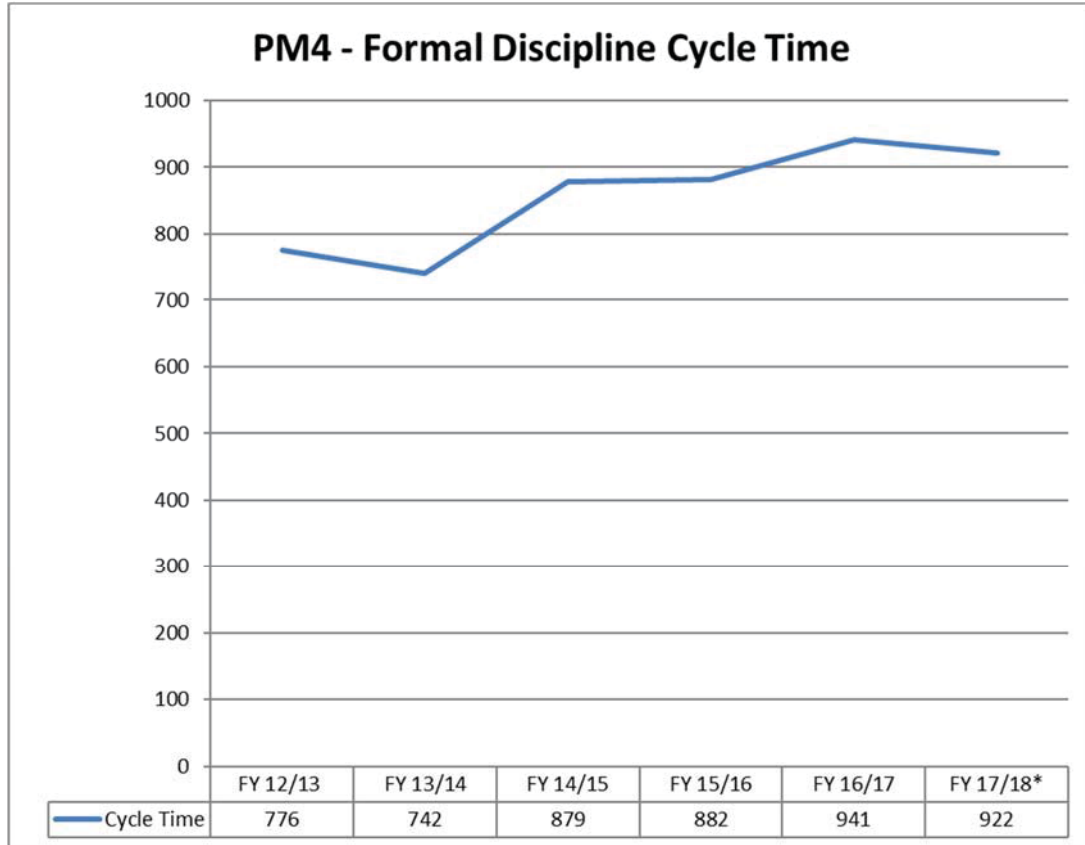
An Inspector I position in the Sacramento field office was filled in October 2017, leaving one remaining Inspector I vacancy. A candidate was offered the job however, subsequently declined. The position will be re-advertised in January after the new Inspector I exam list is released. February 2018 is the anticipated date interviews for this vacant position will be held.

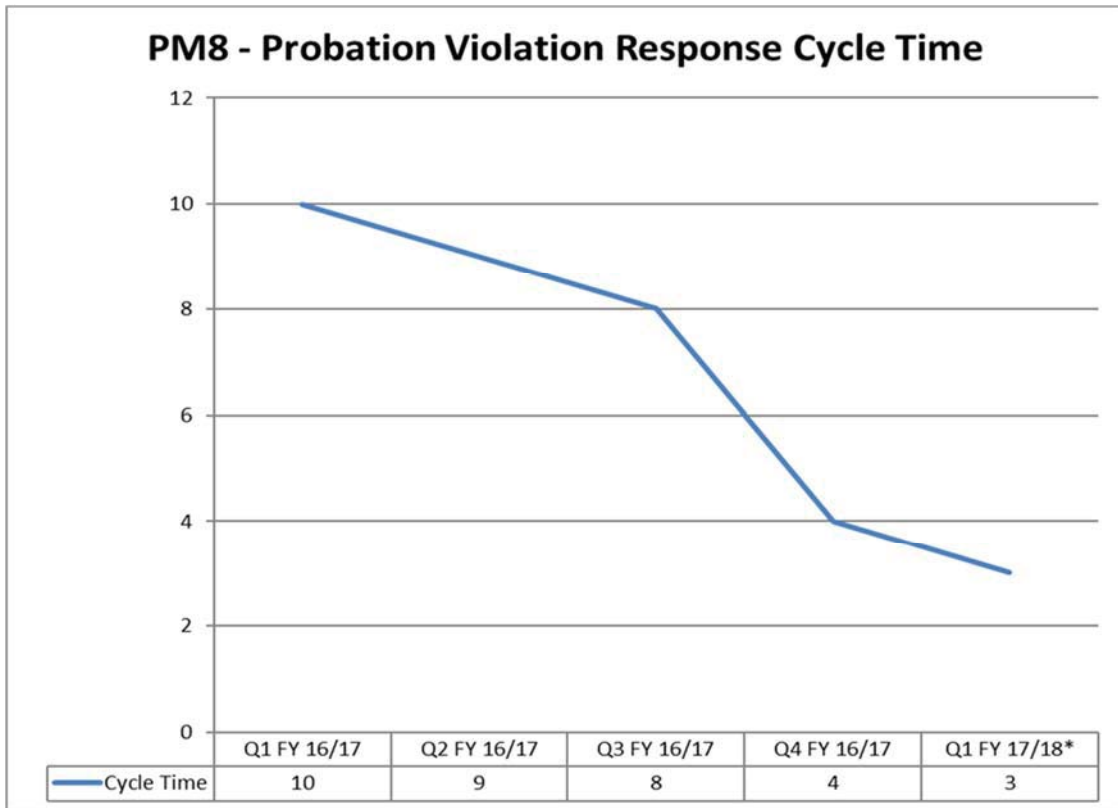
Enforcement Performance Measures:

The charts below depict workload statistics regarding the number of complaints received, which includes complaints and arrest notifications (PM1), the average number of days to initiate a complaint and assign it to an analyst (PM2), the average number of days it takes to complete a case that has not been transmitted to the AGO for disciplinary action (PM3), and the average number of days it takes to complete a case that has been transmitted to the AGO for disciplinary action (PM4). PM7 captures the average number of days from when a probation inspector is assigned a case to when the inspector makes the initial telephone call to the probationer to set up the face-to-face intake interview. PM8 captures the average number of days from when a probation inspector confirms/supports with evidence that a violation of a term and condition of probation may have occurred to when management has provided approval for appropriate action to be taken for the violation of probation. Reports capturing PM7 and PM8 statistics were implemented in July 2016, and reflect fiscal years 16/17 and July 1 through December 31, 2017.

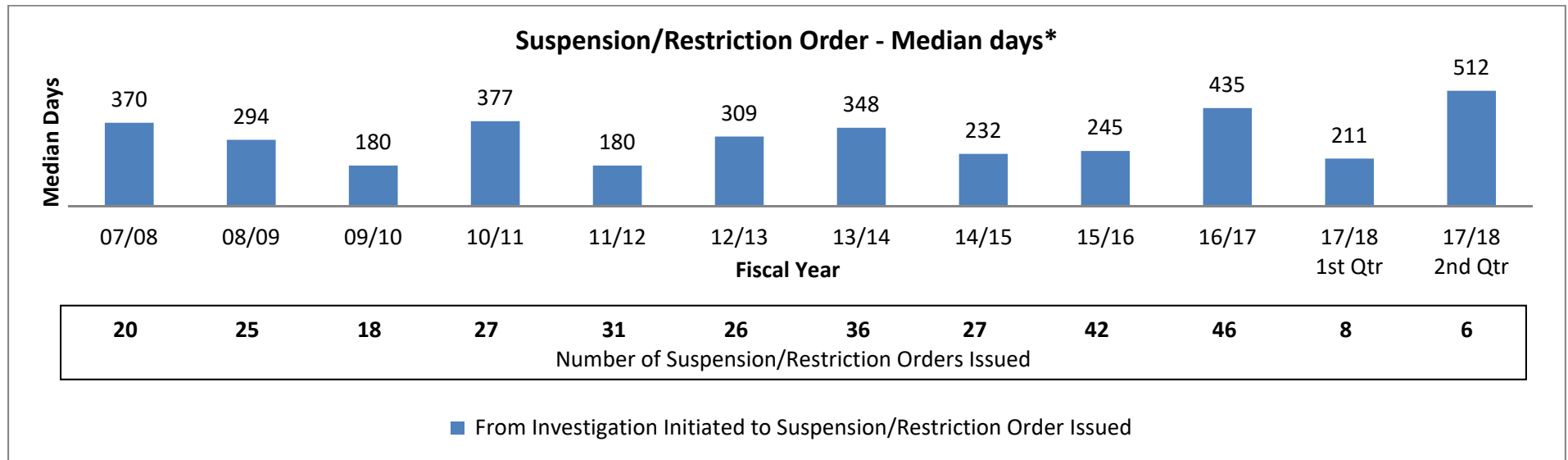
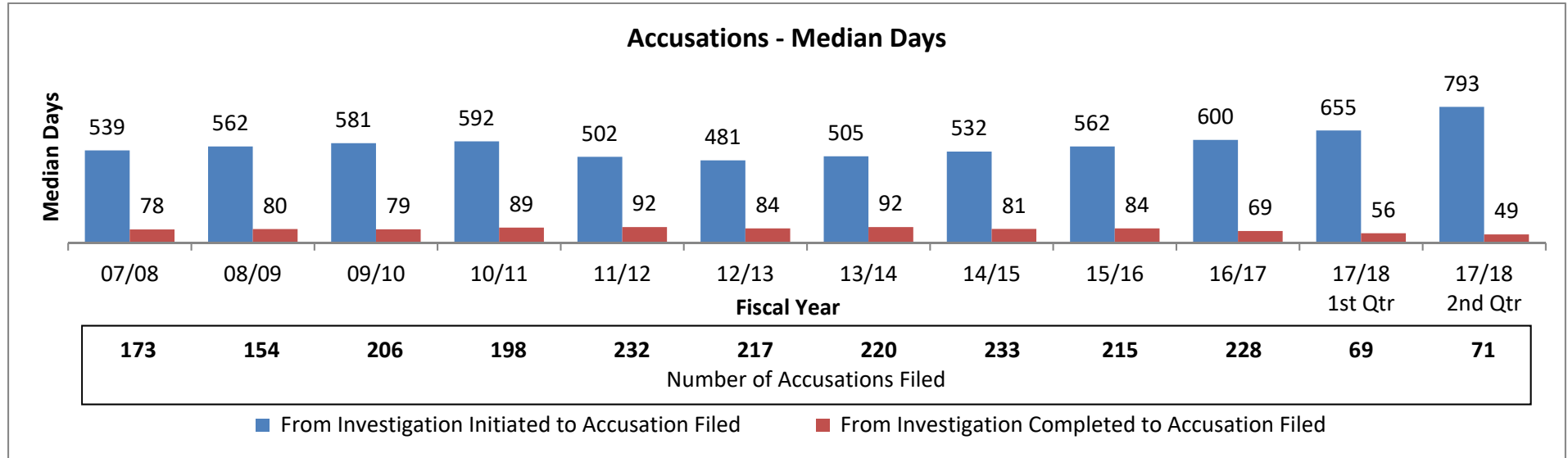
Vertical Enforcement/Prosecution Cases - Median Days

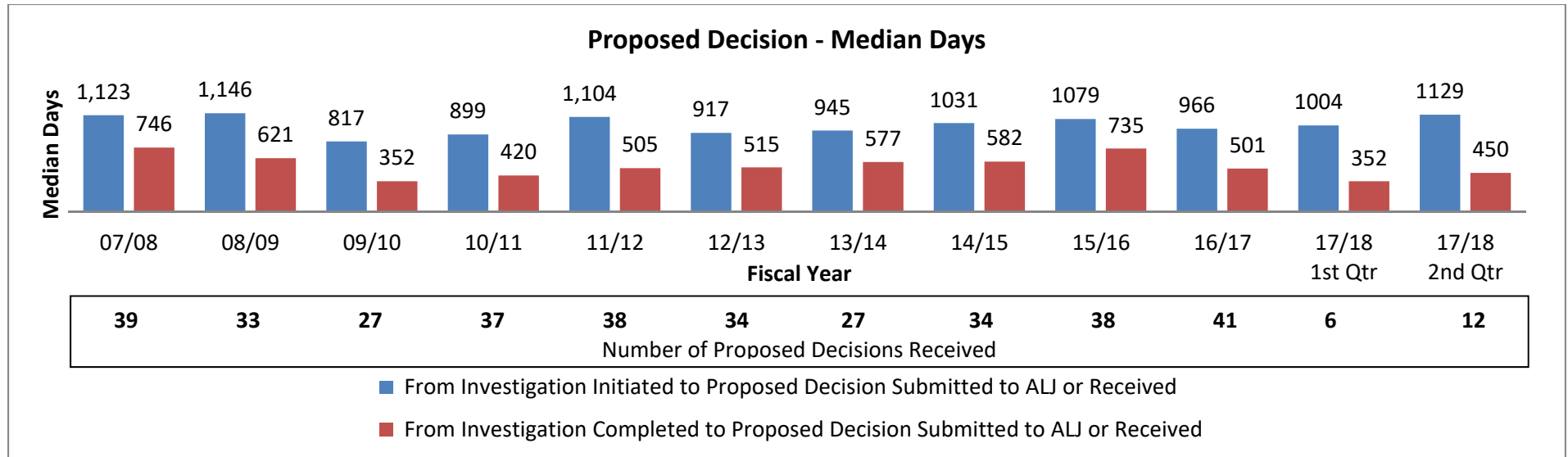
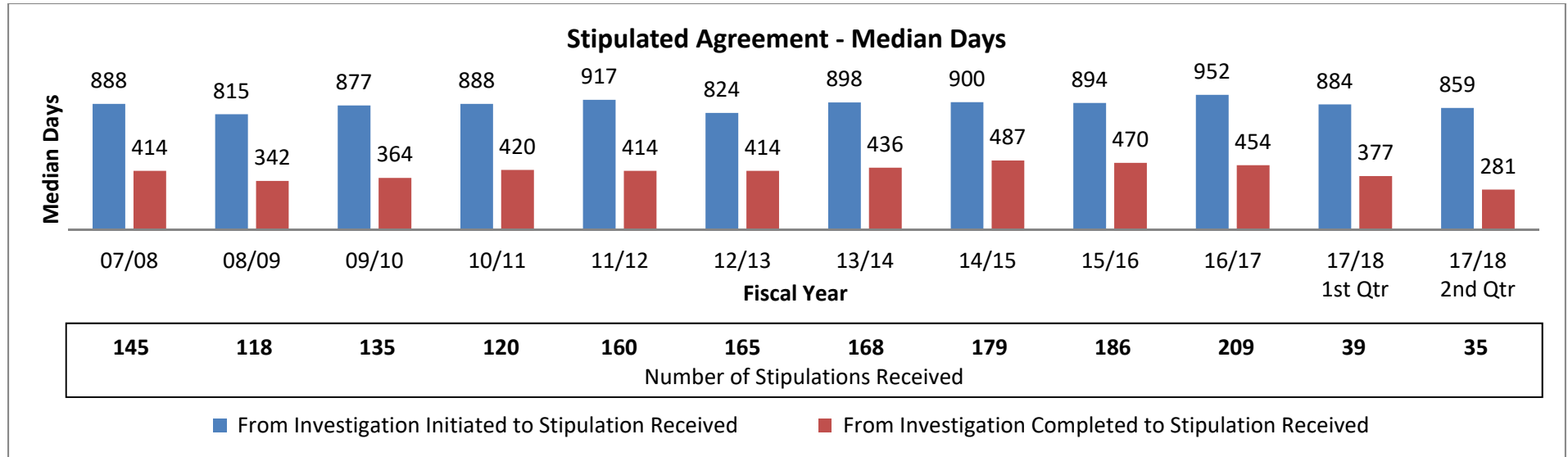
Vertical Enforcement/Prosecution Cases - Median Days

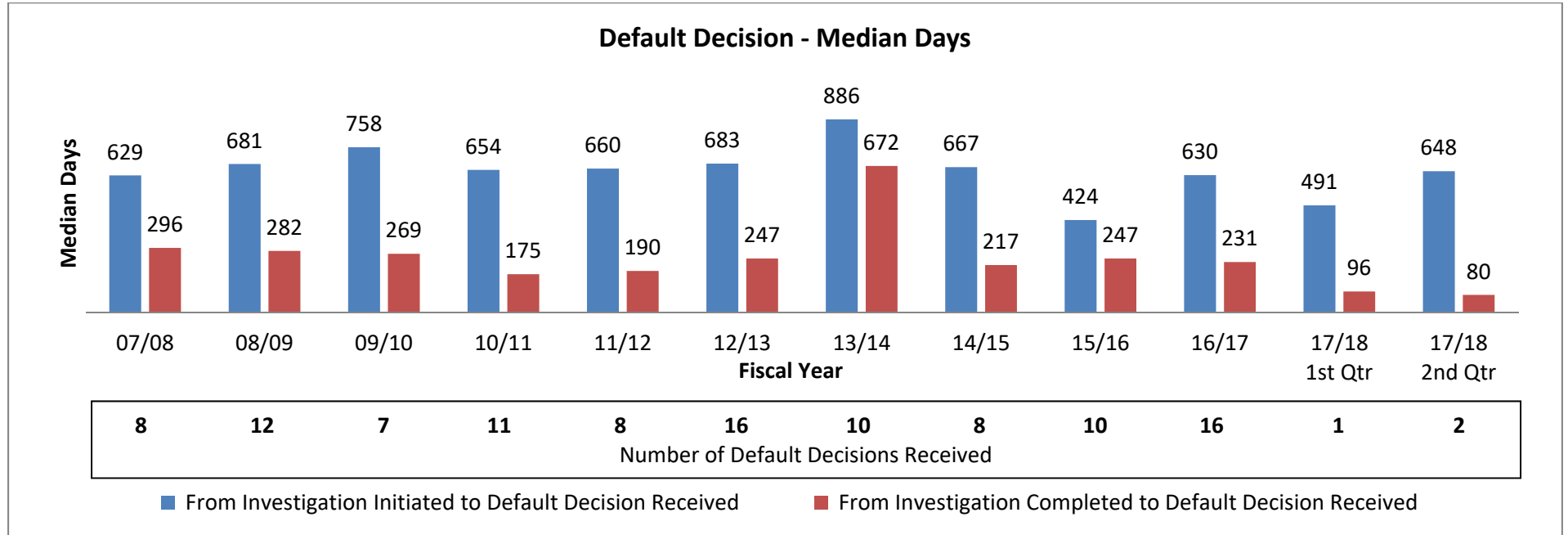
