DISCIPLINARY ACTIONS INCREASE SHARPLY

The table below indicates a significant increase in the number of disciplinary cases processed by the Board in 1974 compared to preceding years. The total number of accusations pending at the beginning of this year is double that of last year. The average number of pending investigations in 1974 increased by 214 cases compared to 1973 and the total number of accusations filed in 1974 was 93 compared to 70 in 1973. This upward trend is continuing this year and is not expected to decrease.

Assemblyman William Campbell, of Los Angeles, will introduce legislation to acrease the number of members on District Review Committees to handle the increasing case loads. A public member will also be added to each DRC under this proposed legislation.

BOARD REPORTS ON MALPRACTICE

The Board of Medical Examiners is required under the Business and Professions Code to submit reports to the Legislature on all malpractice settlements and judgments reported by insurance companies. The statistical summary below reflects the information supplied to the Board over the past four years.

Governor Edmund G. Brown, Jr., called a special session of the legislature on May 19 to study the current malpractice insurance situation and propose legislation to ease the crisis. Approximately 25 bills have been introduced during this session dealing with professional liability.

Financial Awards Double

Malpractice claims settlements have been steadily increasing since 1971. Only 503 settlements were awarded in 1971 compared to 869 in 1974. Financial awards for all settlements have more than doubled in the last four years. Total claims in 1971 amounted to \$15,169,935.00 compared to \$32,819,024,72 in 1974.

District Review Committees hear disciplinary cases, which require medical knowledge, and recommend proposed decisions to the Board. Each Committee represents a separate geographical area of the state. Members of DRC's are appointed by the Governor and serve four-year terms.

mained fairly steady over the past several years. Only six more companies reported in 1974 compared to 1973.

M.D. Claims Increase

Claims by licensed M.D.'s have risen \$16,176,810.22 since 1971 and the total number of claims has increased by 370 cases since 1971. Statistics for M.D. claims for 1974 show an increase of \$7,959,553.86 over the preceding year and 208 more claims were awarded.

Podiatry Claims Decrease

The total number of claims for podiatrists has decreased since 1971 and 1972. Only one case was awarded in 1973 (\$75,000.00) and 1974 (\$6,000.00). The number of institutional claims have also decreased since 1972 but financial awards have increased. In 1971, eight claims were awarded totalling \$193,000.00. However, in 1974 six claims were awarded amounting to \$1,696,779.50.
