

### Are You Reporting Communicable Diseases and Conditions As Required?

It has been brought to the attention of the Medical Board of California (Board) that some physicians and surgeons are not reporting certain communicable diseases and conditions to authorities within specific timeframes, as legally required.

Failure to report or delayed reporting can



result in the unnecessary spread of disease and preventable illness. It can also result in discipline for physicians. Failure to report communicable diseases and conditions listed in the *California Code of Regulations, Title 17, section 2500* is a misdemeanor pursuant to *Health and Safety Code section 120295*. California law punishes violations by a fine of \$50 to \$1,000, or by imprisonment for a term of not more than 90 days, or by both. Each day that the violation continues is a separate offense.

In general, conditions that require urgent public health action require immediate reporting by telephone. Examples include: meningococcal infections, anthrax, rabies, plague, measles, botulism, Domoic acid poisoning (amnesic shellfish poisoning), diphtheria, cholera, Zika virus, *Escherichia coli*, Shiga toxin, and others.

Infections and diseases such as amebiasis, babesiosis, campylobacteriosis, listeriosis, malaria, and others require reporting by electronic transmission (fax, telephone or email) within one working day of identification. Less urgent conditions, such as hepatitis C, Lyme disease, mumps, Coccidioidomycosis, and others can be reported within one week.

## Editor's Spotlight

Please read President Dev GnanaDev's message on *page three* to learn more about upcoming changes contained in the Medical Board of California's Sunset Bill, extending the Board's administrative and regulatory functions through January 1, 2022. As an example of one impending change, the postgraduate training requirement for California physicians will increase from one or two years to three years, regardless of where the applicant attended medical school. This lengthened postgraduate training requirement takes effect on January 1, 2020.

Stem cell "clinics" have popped up around the country, offering untested treatments for everything from cancer to macular degeneration, sometimes with tragic outcomes. # President's Message



I'm very happy to report that Governor Jerry Brown signed Senate Bill 798, (Hill, Chapter 775, the Medical Board of California's (Board) Sunset Bill) into law on October 13, 2017.

The bill extends the administrative and regulatory functions of the Board until January 1, 2022. In addition, this bill includes many of the new issues requested by the Board in its 2016 Sunset Review Report, including language to make changes to accommodate the continuing evolution of medical training, to improve the efficiencies of the Board's Licensing and Enforcement Programs, and most importantly, to enhance consumer protection. Here are some of the changes that take effect January 1, 2018, unless noted otherwise:

- Amends existing law to allow the Board to post information in a more consumer friendly manner on notice to consumers' postings.
- Amends existing law regarding the prompt revocation of physicians who are required to register as sex offenders, and changes it to an automatic revocation to allow the revocations to be processed in a more expeditious manner.
- Allows the Board to issue a two-year license to its licensees beginning July 1, 2018, instead of using

a physician's birth date to calculate license expiration dates. Licenses issued before July 1, 2018 will continue with the same expiration dates.

 Beginning January 1, 2020, changes the postgraduate training requirement from one or two years to three years for all applicants, regardless of where they went to medical school.
Creates a postgraduate training license to allow an individual in a postgraduate training program in California to continue in that program.
Deletes the requirement for the Board to approve international medical schools.

The Board would like to thank Senator Hill and his staff for their diligent work on this bill and Governor Brown for signing this bill into law. In addition, the Board would like to thank Board staff members for their hard work on the bill. Good job, everyone.

Doctors are also required to report outbreaks or "unusual diseases" to the Local Health Officer in the jurisdiction where the patient lives. Local Health Officers must then report specified diseases and conditions to the California Department of Public Health (CDPH).

## Reportable Diseases: When and How to Report Them

Information about which diseases and conditions are reportable, when to report, and how to report is available on the CDPH website at: *https:// www.cdph.ca.gov/Programs/CID/DCDC/Pages/ Information-for-Health-Professionals.aspx*. The list of the diseases and conditions that must be reported by health care providers is in the *California Code of Regulations, Title 17, section 2500*, which also lists the reporting time for each disease and condition.

Disease reporting enables public health officials to carry out three important tasks:

- Some conditions require immediate public health action. For example, public health officials follow up on cases of meningococcal disease to identify contacts and provide postexposure prophylaxis.
- 2. Local health departments and CDPH monitor a range of conditions and use disease reports to determine disease incidence, groups at risk, and disease trends. These data inform health care providers and the public about disease risks and inform disease control policy. For example, reports of pertussis are used to determine when there are cyclical peaks of disease; the information collected can help health care providers assess the risk of pertussis in their patients and guide vaccination outreach.
- 3. Disease reports from health care providers are often the first indication that there is an outbreak or public health emergency. Failure to report or delayed reporting can result in inaccurate disease information for health care providers and the public.

#### **Reporting Requirements**

Health care providers must report to the local health officer where the affected patient resides. Those working in settings with multiple providers should inquire about the reporting procedures in their facility. The administrator of a facility where multiple providers practice is responsible for establishing procedures to ensure diseases are reported. Many hospitals and clinics have systems for centralized reporting. However, **it is ultimately the responsibility of the health care provider to ensure that reporting occurs**.

Health care providers should contact the local health department(s) in their area to determine the appropriate phone/fax numbers and mailing addresses for reporting. A list of local health departments is available at: *https://www.cdph.ca.gov/Programs/CCLHO/Pages/CCLHO/Pages/CCLHOLandingPage.aspx*.

Electronic reporting is possible via the Provider Portal, a CDPH tool that enables health care providers to log on to a secure, web-based system and submit case reports online. More information about the Provider Portal is available from local health departments. In addition, CDPH is currently working with local health departments, electronic health record system vendors, and health care systems to establish mechanisms for automated, electronic disease reporting from electronic health records. This is part of a national effort to enable "meaningful use" of electronic health records. Beginning in January 2018, health care providers will be able to register their intent to submit electronic case reports to CDPH. The shift to electronic reporting systems will enable more rapid and more efficient disease reporting. #### **Board Enforcement for Failure to Report**

If the Board receives a complaint alleging that a licensee failed to report communicable diseases or conditions, a complaint is opened against the licensee as part of the Board's standard enforcement

### Expert reviewer applications are accepted continuously

If you live in California and have a full-time active practice in California, the Medical Board of California (Board) encourages you to apply to be an expert reviewer (expert). The Board established its Expert Reviewer Program in July 1994 as an impartial and professional means to support its investigation and enforcement functions. Experts assist the Board by providing reviews and opinions on Board cases and conducting professional competency, medical and psychiatric evaluations.

The Board is currently looking for experts in the following specialties: allergy and immunology; addiction medicine with added certification in family or internal medicine or psychiatry; colon/rectal surgery; dermatology; family medicine;



gastroenterology; neurological surgery; neurology; pathology (preferably from the following counties: Orange, Riverside, Sacramento, San Bernardino, San Diego, San Francisco, and Ventura); pain medicine; pediatric gastroenterology; pediatric surgery; pediatric cardiac surgery; pediatric pulmonology; plastic surgery (with expertise in Neograft hair transplant and gender reassignment); psychiatry (forensic and addiction); surgery (general and endocrine surgery); thoracic and cardiac surgery; urology (general and gender reassignment); and vascular surgery; as well as licensed midwife reviewers.

Actively practicing physicians from all other specialties not listed above are also welcome to apply and participate in the program. Physicians must be board certified, have been practicing their specialty for a minimum of three years after board certification, have no current complaints, no prior discipline, and must be willing and available to testify in court.

The Board also needs midwife expert reviewers throughout the state of California. Licensed midwives must have an active midwifery practice for the past two years, have no current complaints, have no prior discipline, and must be willing and available to testify in court.

process. Evidence is gathered and evaluated to determine whether the licensee has violated the law. If a violation is confirmed, it is likely to lead to issuance of a citation and fine. A citation and fine is an alternative method by which the Board can impose a sanction and take an administrative action against a licensed individual found in violation of a law or regulation governing the practice of medicine. The Board has authority to issue citations and fines to physicians and allied health licensees for specified violations of law. Citations are not discipline, although they are public record. A copy of

the citation is posted on the physician's profile on the Board's website and must be provided to the public for three years from the date of resolution. Failure to report communicable diseases or conditions may result in the issuance of a citation for a violation of Health and Safety Code sections 120250, 121362 or 121363, or California Code of Regulations, Title 17, section 2500.

Additionally, *Business and Professions Code section 2236* states that the conviction of any offense substantially related to the qualifications, functions, or duties of a physician constitutes unprofessional conduct that can be cause for disciplinary action. Therefore, if it is reported to the Board that a licensee failed to report communicable diseases or conditions in violation of the California Code of Regulations and was convicted of a misdemeanor, disciplinary action against the physician's license may also be taken. Discipline could include suspension or revocation of the physician's license, or the licensee could be placed on probation with the Board.

# Legislator Profile: Mike A. Gipson



Born in Watts, Assemblymember Mike A. Gipson was elected in November 2014 to represent California's 64th Assembly District, including the communities of Carson, Compton, Gardena, Harbor Gateway, Lynwood, North Long Beach, Rancho Dominguez, South Los Angeles, Torrance, Watts/Willowbrook and Wilmington.

During his first Assembly year, he was appointed chair of the powerful Joint Legislative Audit Committee (JLAC). Under his leadership, JLAC convened nine hearings and 21 audit requests.

In 2016, Assemblymember Gipson was appointed (and re-appointed in 2017) by Speaker Anthony Rendon as Democratic Caucus Chair. As part of the Speaker's leadership team, Assemblymember Gipson is responsible for driving the legislative decision-making process for the Democratic Caucus, holding weekly meetings to discuss and set the caucus's priorities. He is a member of several standing committees including the Assembly Business and Professions Committee, which has jurisdiction over health care professional licensing, occupational licensing, vocational education, and more.

Assemblymember Gipson began his second term by authoring legislation to close a deadly loophole in the California Penal Code, providing internet-related services for foster and incarcerated youth, and establishing a working group to bring back Career Technical Education for grades K-12. He was also successful in securing \$11.3 million for Compton Community College to support the college's transition into an independent institution.

As part of the 2016-2017 state

budget, Chairman Gipson was able to assist in establishing the first-ever state earned income tax credit for working families, repeal the maximum family grant to lift 135,000 children out of poverty, and approve a path to a \$15/hour minimum wage in California. As Chair of the Assembly Select Committee on Infectious **Diseases in High Risk Disadvantaged** Communities, Gipson led the effort to develop a statewide "Getting to Zero" campaign for zero new HIV (human immunodeficiency virus) infections, zero

HIV deaths, and zero stigma and discrimination in California.

Most recently, Assemblymember Gipson led the effort as Democratic Caucus Chair to pass a \$52 billion transportation package focused on road safety improvements, pothole and highway repair, and job creation. Along with bipartisan effort, he was able to help spearhead a comprehensive cap and trade package of air quality provisions to address emissions from multiple sources that impact public health.

Gipson currently lives in Carson with his wife, Le Cresha. They have two sons and two grandchildren. Their third son, D'Ance, passed away at three years old as a result of a hit-and-run incident.

# You Asked For It

### Questions Received from the Web

## **Q.** Who is allowed to administer Botox and other dermal fillers in my medical office?

A. As a licensed physician, you may inject Botox and other dermal fillers. A registered nurse or physician assistant may inject Botox under your supervision and/or direction. Botox and other dermal fillers may not be administered by either a licensed vocational nurse or a medical assistant.



## **Q.** My hospital pays to have my name embroidered on my lab coat. I would like to have my nickname added. Is this permitted?

A. You must use your name as it appears on your California medical license so patients and other staff are able to properly identify you. You may add a nickname beneath your legal name.

## **Q.** Is my medical assistant permitted to draw up lidocaine to have a prefilled syringe ready for my administration?

A. No. Medical assistants are not permitted to administer any type of anesthetic, nor are they permitted to draw up or reconstitute any anesthetic for use by another medical provider.

## **Q.** I understand my medical assistant is not permitted to insert a catheter. Is he/she permitted to remove a catheter?

A. No. A medical assistant is not permitted to insert or remove a catheter from a patient.

#### Q. I am getting married and changing my legal name to my husband's last name. However, I have been licensed for many years under my maiden name and want to keep using this name professionally. Am I allowed to legally continue using my maiden name?

A. **California Business and Professions Code section 2021(c)** states: "Each licensee shall report to the board each and every change of name within 30 days after each change, giving both the old and new names." There is no exception in the law for the continued use of a maiden name professionally after a licensee legally changes the name upon marriage.



### FDA Taking Action to Protect the Public from Unproven and Potentially Dangerous Stem Cell Therapies

U.S. Food and Drug Administration (FDA) Commissioner Scott Gottlieb, M.D., affirms that "One of the most promising new fields of science and medicine is the area of cell therapies and their use in regenerative medicine. These new technologies ... hold significant promise for transformative and potentially curative treatments for some of humanity's most troubling and intractable maladies." That said, the FDA is stepping up enforcement actions against those providing unproven and potentially dangerous products and putting patients at risk. The FDA has taken recent actions to protect public health.

Marketing stem cell products without FDA approval may be a violation of the Food Drug & Cosmetic Act. The FDA

recently inspected US Stem Cell Clinic in Sunrise, Florida and found that the clinic was processing adipose tissue into stromal vascular fraction and administering the product intravenously or directly into the spinal cord of patients to treat a variety of serious diseases/conditions, including Parkinson's disease, ALS (amyotrophic lateral sclerosis, also known as Lou Gehrig's disease), COPD (chronic obstructive pulmonary disease), heart disease, and pulmonary fibrosis. The FDA had not reviewed nor approved any biological products manufactured by US Stem Cell Clinic for any use. A warning letter was issued on August 24, 2017, to the company and the Chief Scientific Officer for using the unapproved product and for significant deviations from current good manufacturing practices, including some that could impact the sterility of their products, putting patients at risk. The company has been advised to take prompt action to correct all deviations and that failure to do so may result in regulatory action (e.g. seizure and/or injunction). The FDA also took action to prevent the use of a potentially dangerous and unproven treatment from StemImmune, Inc., in San Diego, California. The treatment was administered to cancer patients at the California Stem Cell Treatment Centers in Rancho Mirage and Beverly Hills, California. The U.S. Marshals Service seized five vials of Vaccinia Virus Vaccine (Live) – a vaccine that is reserved only for people at high risk for smallpox (e.g. some members of the military). Each vial contained 100 doses of the vaccine; one vial

was partially used. The vaccine is not commercially available – cause for concern. The seizure came after recent FDA inspections confirmed that the vaccine was used to create an unapproved stem cell treatment and administered to patients with potentially compromised immune systems. The vaccine posed a potential for harm, including myocarditis and pericarditis. The unproven and potentially dangerous treatment was being injected intravenously and directly into patients' tumors.

The FDA plans to advance a comprehensive policy framework this fall to clearly delineate what constitutes an individualized treatment being performed by a doctor within the scope of his/her medical practice and what constitutes a medical product that is currently subject to FDA regulation. Dr. Gottlieb asserts, "Many of the individualized treatments fall clearly outside the FDA's pre-market requirements. For those that currently fall across the line and are subject to the FDA's existing pre-market review, we want to make sure the process for gaining FDA approval is efficient." But he then stated, "We will also continue to take steps to keep those who would exploit this promising area from harming patients and abusing the public's trust."

### California Stem Cell Law Requires Patient Warnings

On October 2, 2017, Governor Jerry Brown signed **Senate Bill 512, Chapter 428** (Hernandez), which requires California health care practitioners to post a specified notice in a prominent location in their offices to inform patients if they are performing one or more stem cell therapies that are not approved by the U.S. Food and Drug Administration (FDA).

The notice must be at least 8.5 X 11 inches and written in no less than 40-point type. It must read as follows: "THIS NOTICE MUST BE PROVIDED TO YOU UNDER CALIFORNIA LAW. This health care practitioner performs one or more stem cell therapies that have not been approved by the United States Food and Drug Administration. You are encouraged to consult your primary care physician prior to undergoing a stem cell therapy."

Prior to performing the initial stem cell therapy, the law requires a health care practitioner to provide the patient with the same notice, the same size and printed in the same size type, in writing. The law takes effect January 1, 2018.

After the first violation, the Medical Board of California (Board) may cite and fine the physician up to \$1,000 for each violation of the law — for not posting the information or not providing it to patients.

Beginning with its 2018-2019 annual report, the Medical Board of California is required to report all of the following with regard to licensees who provide stem cell therapies:

- The number of complaints received.
- Any disciplinary actions taken.
- Any administrative actions taken.

The new law does not apply to a licensed health care practitioner who has obtained approval for an investigational new drug or device from the FDA that uses human cells, tissues, and cellular and tissue-based products (HCT/Ps) that are regulated by the Center for Devices and Radiological Health as medical devices and those that are regulated by the Center for Biologics Evaluation and Research.


### Steven M. Thompson Loan Repayment Awards Can Ease Medical School Debt Burden

Physicians working in underserved areas can apply for up to \$105,000 in student loan repayment funds. The Steven M. Thompson Physician Corps Loan Repayment Program (STLRP) application cycle opened on November 1, 2017. The deadline to apply is January 31, 2018.

Since its inception, STLRP has received 1,228 applications. The program has awarded more than \$47 million and monitored the progress of 538 physicians providing direct patient care in 47 of California's 58 counties. Consistent with the intent of the program, 80 percent of the total recipients are certified in a primary care specialty.

STLRP applicants are awarded based on their practice setting, medical specialty, and ability to meet the cultural and linguistic needs of the patients they serve. All recipients must serve in a medically underserved area (MUA) where more than 50 percent of its patients are uninsured, Medi-Cal beneficiaries, or beneficiaries of another publicly-funded program serving patients who earn less than 250 percent of the federal poverty level. Priority consideration is given to the applicants best suited to meet the cultural and linguistic needs of patients, as determined by meeting one or more of the following criteria:

- Speaks a Medi-Cal threshold language.
- Comes from an economically disadvantaged background.
- Has significant training in culturally and linguistically appropriate service delivery.
- Has three years of experience working in an MUA or with a medically underserved population.
- Has obtained a license to practice medicine in any state of the United States, or any province or territory of Canada, within the last 15 years.

## Prospering on Probation

**Editor's note**: Here is one physician's candid and thoughtful assessment of how being put on probation by the Medical Board of California helped save his life and his career. The physician's name is being withheld because he has completed the probationary term and moved on with his medical career. The Board is grateful to this doctor for sharing his insights and suggestions for other physicians who might find themselves in a similar situation.



I understand that you were placed on probation for a period of seven years, successfully completed your probation, and that your license to practice medicine in California has been fully reinstated. Is that correct?

That's correct.

I understand that an issue leading to your being placed on probation was substance abuse. Can you elaborate a little on the topic, such as how and why this became a problem, and how serious it was? How did it affect your behavior? In your opinion, how did it affect your ability to practice medicine?

Substance abuse runs in my family. We tend to take everything to the extreme. However, there comes a point when using alcohol or drugs that it's not just for fun, but to cope with stress, and in medicine there is a tremendous amount of stress — mental, emotional and physical. I knew that when I noticed myself using that way, that the check would one day come due. But I had what seemed like my whole life invested in my career,

and so I gambled that I would be able to get to a point of security and stability first. I hesitate to describe how bad it got, because addicts reading this might have a tendency to compare stories and in so doing rationalize their own behavior. Suffice it to say there were many times when I wasn't practicing my best medicine because of alcohol and drugs and I am very sorry about that.

#### What are your thoughts about probation in general? Did being on probation help you with being rehabilitated? If yes, in what ways?

Needless to say, I wasn't happy about probation initially. The worst part was that the local newspaper picked up my story and it ended up on a wire service. It was all very public. You just have to focus on your own journey and try to be the best person you can be.

It was very helpful to me in the early days of my recovery to be in a group with other doctors. I also went to 12-step several times a week. All in all, it probably took me two years to get to a point where I could see a bright future for myself without alcohol and drugs. I am grateful that my family was able to support me to that point.

## What did you do to ensure compliance with the terms of your probation?

Having a support system is crucial. That starts with your family and friends, but also includes your probation monitor, any groups you belong to, your therapist if you have one, and, ultimately, your employer. I marked off every day on the calendar so as to be sure to call in for testing and so I knew when things were due.

#### What did you learn from being on probation?

It can seem overwhelming in the beginning but over time it supports the development of healthy habits. Although I am very proud to have completed probation successfully, for the most part I didn't really mind it. I can't deny that it was an important part of maintaining my sobriety.

#### Any other thoughts you have about the process? Any tips you might offer to other doctors who find themselves on probation?

The key to prospering on probation, and to recovery in general, is to learn to take direction. You don't want to get through it by trying to beat the system that is designed to help you be an ethical practitioner. Take this forced opportunity to establish a healthy, balanced, sustainable lifestyle — maybe for the first time.

### Steven M. Thompson Physician Corps Loan Repayment Program Recipient

Dr. Adebanke Lesi is a Nigerian-American who moved from Nigeria to Madison, Wisconsin with her parents and three brothers over 20 years ago. She attended college and medical school in her hometown at the University of Wisconsin. She then moved to Southern California for a pediatrics residency at Children's Hospital Orange County. After graduating in 2012, she began working at The Children's Clinic in Long Beach, a community-based health center for underserved or underinsured children and adults.

In a typical clinic day, she sees 16-30 patients (newborns to 21-year-olds). Additionally, on Tuesdays, she supervises residents training to be pediatricians; after the clinic session, they discuss a general pediatrics topic for the week. Prior to clinic, twice a month, she also holds a teaching session with residents rotating through the clinic that month.

"Actually, when I was much younger, I wanted to be a teacher, like my mom. After we moved to the States, I simply started liking the sciences and my heart shifted to medicine. I credit my parents for always believing I could be anything I wanted and for providing a supportive home for me and my brothers to dream and study. Both because of my affinity for children and because of experiences within my family, I knew I wanted to be a pediatrician. I grew up with an older brother who has a congenital medical illness; I wanted to help families like mine, with children with tough, chronic diagnoses. I also wanted to help give a healthy start to as many children as I could. Because of my cumulative experiences within communities in such places as Nigeria, Guatemala, Peru, New Orleans, and Milwaukee, I always wanted to work with a communitybased organization, within a diverse population, with children at high risk of medical problems," Dr. Lesi said.

"Ultimately, I still became a teacher — what I love most about my job is educating a family on a medical problem. It takes time, but it helps a family become longterm partners in improving their children's health problems. Taking the extra time to really break down what asthma or eczema is and how each medicine works, for example, can help improve compliance with treatments. I often think of the adage - 'It takes a village to raise a child.' With each family partnership, I'm building a village, helping to raise healthier children.

"If I could give advice to any young person looking to become a doctor, my strongest advice is don't be afraid to ask for and receive help. In high school and undergrad, I felt I was smart enough to handle things on my own, and asking questions felt like being weak. Many mentors later,



I know better. Also, in med school and residency, I learned to use study buddies with great success. As my career progressed, it has really helped to have the unwavering support of my work family at The Children's Clinic. We work cooperatively, consult with each other and support each other – just like my family has always done," Dr. Lesi said.

She feels very grateful and honored to be selected as a Steven M. Thompson Physician Corps Loan Repayment Program recipient. "I am so appreciative there is a loan repayment program providing much-needed relief from the stress that comes with medical school loans. The Steven M. Thompson Loan Repayment Program has allowed me to keep the job I want, in a community, working closely with families I care about and providers I love and respect."

#### Zika Warnings Still Necessary

The California Department of Public Health (CDPH) has advised pregnant women - as well as men and women of childbearing age - to avoid areas with Zika virus, which include Mexico and Puerto Rico. Zika can cause microcephaly and other severe brain defects in the fetus. The virus can be transmitted sexually or by mosquito bites. By early November, there had been 609 cases of travelassociated infections in California since 2015, but no locally transmitted cases of Zika. Both Texas and Florida have experienced locally transmitted Zika cases. Eight infections in California resulted in liveborn infants with birth defects consistent with Zika. The good news is that the number of cases reported in 2017 to date (101) is far lower than total reported in 2015-16 (508). "The best thing pregnant women can do to protect themselves and their unborn baby is to stay away from areas where Zika is circulating," said CDPH Director and State Health Officer Dr. Karen Smith. #### FDA Studying Gadolinium Retention

The U.S. Food and Drug Administration (FDA) continues to study retention of the heavy metal gadolinium in the brain, bones, and skin following use of gadolinium-based contrast agent (GBCA) for magnetic resonance imaging (MRI). MRIs are used to locate cancerous tumors, infections, or bleeding. GBCAs come in two types: linear GBCAs and macrocyclic GBCAs. Citing scientific publications, the FDA reports that linear GBCAs retain more gadolinium in the brain than macrocyclic GBCAs. The FDA's National Center for Toxicological Research is studying brain retention of gadolinium in rats to determine whether the deposits are harmful, according to the website. "To date, the only known adverse health effect related to gadolinium retention is a rare condition called nephrogenic systemic fibrosis (NSF) that occurs in a small subgroup of patients with pre-existing kidney failure," according to the FDA website. Health care professionals are encouraged to report side effects to MedWatch. ## Tech Med Corner

#### 3-D Printing Provides Useful Surgical Planning Tools

Surgeons can get a better understanding of a patient's anatomy by printing a 3-D model of the affected area, then studying the model to formulate a surgical strategy, according to an article in The Wall Street Journal. One Mayo Clinic case cited in the article was an 11-year-old girl with a rare tumor in her pelvis that had "spread to the bone and nerves of her sacrum and was encroaching on her hip socket." Using a 3-D model of the girl's pelvis, "scaled to size and showing her bladder, veins, blood vessels, ureters and the tumor," the medical team devised a plan that enabled removal of the entire tumor without amputating one of the child's leas, as would have been considered without the 3-D model, according to the article. "There is nothing like holding a 3-D model to understand a complicated anatomical procedure," said Dr. Peter Rose, who performed the surgery. "The model helped us understand the anatomy that was altered by the tumor and helped us orient ourselves for our cuts around it," he said. Mayo Clinic reportedly printed about 500 3-D objects last year. (The Wall Street Journal, September 12, 2017)

#### Color-changing Tattoos Tested to Monitor Blood Sugar

Researchers at Harvard and the Massachusetts Institute of Technology (MIT) are testing what are being called biosensing tattoos. Special ink used in these tattoos changes colors in response to a person's blood sugar levels, pH and sodium levels, converting a human body into an interactive display. For example, when blood sugar goes up, the ink changes from blue to brown. Other colors indicate increases in sodium or alkaline levels. The technology, still in the "proof-of-concept" stage, according to a story on CBS News, could replace more invasive testing methods. (CBS News, June 6, 2017)

Hepatitis A Outbreak in California - Limited Adult Vaccine Supply Forecast for Fall 2017

An outbreak of hepatitis A virus (HAV) disease is ongoing in California among persons experiencing homelessness or using illicit drugs in settings of limited sanitation. In San Diego County, at least 507 HAV cases and 19 deaths have been reported since November 2016. In Santa Cruz County, at least 73 cases have been reported since April 2017. Cases due to the same strain of HAV have been identified in these and other counties as well as in several other states.

HAV is being spread person-to-person in this outbreak. As the use of adult hepatitis A vaccine has increased to help control this outbreak and outbreaks in other states, the supplies for adult immunization for the last quarter of 2017 have become constrained.

In California, hepatitis A transmission and risk vary by county and can vary within counties. CDPH therefore recommends the following:

- 1) Vaccines should be prioritized for areas with ongoing transmission of hepatitis A and for groups at increased risk of infection in those areas. Please contact your local health department regarding local immunization recommendations, including recommendations regarding occupational groups.
- 2) Depending on vaccine availability, clinicians seeing patients in primary care settings should consider vaccination of persons routinely recommended to receive hepatitis A vaccine. Based on your local health department recommendations, priority should be given to those the individual patients who have the highest immediate risk of acquiring hepatitis A infection or becoming severely ill if infected. Groups that are routinely recommended to receive hepatitis A vaccine include:
  - a. Persons exposed to a case of hepatitis A
  - b. Persons with chronic liver disease
  - c. Men who have sex with men
  - d. Persons using illicit drugs, other than marijuana
  - e. Persons experiencing homelessness
  - f. Travelers to countries where hepatitis A is common
- 3) If adult single antigen hepatitis A vaccine is not available, providers could consider using the combined hepatitis A and hepatitis B vaccine (Twinrix®) for pre-exposure prophylaxis (Twinrix® not recommended for post-exposure prophylaxis) or deferring immunization until additional vaccine becomes available. Vaccine may also be available in pharmacies, and is covered as a pharmacy benefit for several insurance sources, including Medi-Cal fee for service and managed care, as well as several qualified health plans through Covered California.
- 4) All children in the United States are recommended to receive hepatitis A vaccine. At this time pediatric vaccine supplies are not constrained, and recommendations for routine childhood immunization are unchanged.
- 5) To assist with outbreak control, CDPH requests that health care providers contact the local health department immediately during business hours (or 24/7 in San Diego and in Los Angeles) to report a suspected hepatitis A infection in patients experiencing homelessness and/or using injection or non-injection illicit drugs. Please notify the local health department while the patient is still in the facility, as this may be the only opportunity for public health officials to interview the patient.
- 6) To date, there is no increased risk of hepatitis A infection for the general population.

# Explanation of disciplinary language and actions

**"Effective date of decision"** — Example: "March 14, 2012" at the bottom of the summary means the date the disciplinary decision goes into operation.

**"Gross negligence"** — An extreme deviation or departure from the standard of care.

**"Incompetence"** — Lack of knowledge or skills in discharging professional obligations.

"Judicial review pending" — The disciplinary decision is being challenged through the court system, i.e., Superior Court, Court of Appeal, or State Supreme Court. The discipline is currently in effect.

"Probationary License" — A conditional license issued to an applicant with probationary terms and conditions. This is done when cause exists to deny the license application, but limitations can be put in place to protect the public.

**"Public Letter of Reprimand"** — A lesser form of discipline that can be negotiated after or in lieu of the filing of formal charges. The reprimand may include educational and clinical training requirements.

"Surrender" — To resolve a disciplinary action, the licensee has given up his or her license — subject to acceptance by the Board.

**"Revoked"** — The right to practice is ended due to disciplinary action. The license is invalidated, voided, annulled, or rescinded.

### "Revoked, stayed, 5 years' probation with terms and conditions, including 60 days suspension"

- "Stayed" means the revocation is postponed. Professional practice may continue so long as the licensee complies with specified probationary terms and conditions which, in this example, includes 60 days of actual suspension from practice. Violation of any term of probation may result in the revocation that was postponed.

No admissions but charged with gross negligence in the care and treatment of two patients. Physician must complete a prescribing practices course and an education course. Public Reprimand. May 10, 2017

Failed to comply with the terms of his Board-ordered probation by failing to enroll in and complete a clinical training program. Surrender of License. June 19, 2017
