Dr. John V. Pollack Board Consultant

Dr. John V. Pollack was appointed early this year to represent the Southern California region as Medical Consultant to the Board of Medical Examiners. Dr. Robert Quillinan was appointed last year to represent Northern California.

Medical consultants serve as liaison to the Board, and direct investigations and evaluations into the professional conduct of licensees. They serve as expert witness in legal actions of the Board, and inspect medical records to assure compliance with the state law.

Dr. Pollack graduated from Stanford University in 1940 and served his internship and residency at San Diego County General Hospital. He has practiced general surgery in Los Angeles since 1946. Before going into private practice, he

served three years in the U.S. Air Force.

He has served as a Federal Aviation Authority examiner; was certified in 1957 by the U.S. Coast Guard as a surgeon and has served as a medical consultant for Pacific Telephone Company. He has been an Examination Commissioner to the Board of Medical Examiners, a member of the Applicant Qualification panel of the State Personnel Board and has served as surgeon for the Los Angeles police and fire departments. He was chief medical advisor to Blue Shield of Los Angeles County from 1967 to 1971.

Dr. Pollack has been active throughout his professional career in the Los Angeles County Medical Society, the California Medical Association and the American Medical Association.

Current Health Care Legislation Summarized

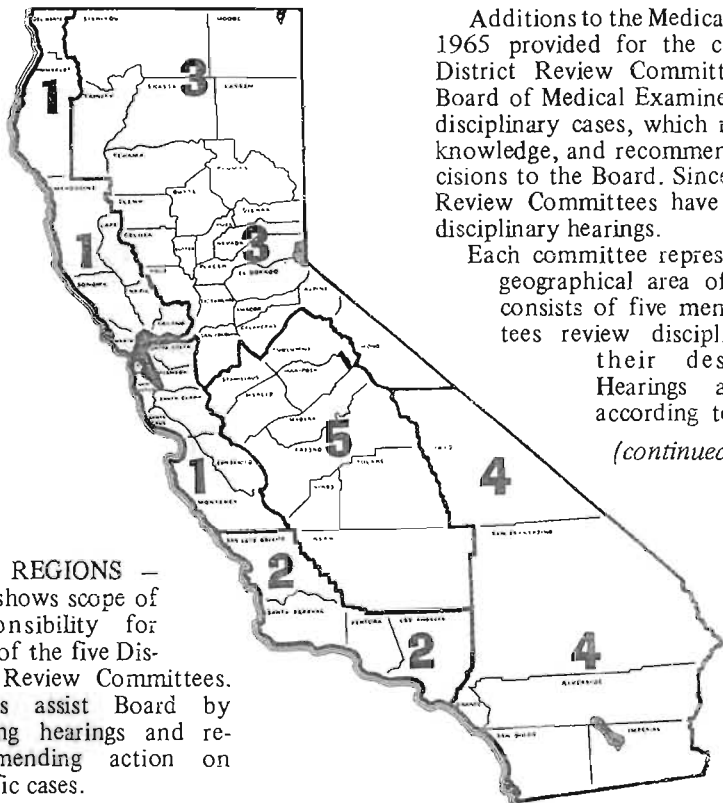
Assemblyman Gordon Duffy, of Hanford, has authored several bills relating to health care. A brief summary of three of these bills follows:

AB 3273 - Specialty Practices. Requires certification before a physician is designated as a medical specialist. This bill would require the Board of Medical Examiners to establish minimum standards of training for fields of specialty practice to qualify for certification.

AB 3187 - Nurse Practitioners. Creates a Nurse Practitioner Council within the Department of Consumer Affairs to supervise nurse practitioner activities. The proposed new board would be responsible for setting standards, issuing licenses and supervising nurse practitioners in the State. The board also would be responsible for establishing categories of nurse practitioners, such as pediatrics, obstetrics, gynecology, primary care, critical care, anesthesiology and mental health.

AB 2971 - Foreign Medical Graduates - Requirements for licensure. Revises requirements for licensure as a physician for foreign medical school graduates. Additionally, the designation "M.D." would be included in physicians licensure certificates. This would permit persons licensed as physicians to utilize the title "M.D." following their names, thereby changing the precept that "M.D." represents an educational degree. Under the bill, the letters "M.D." would represent only an indication of one's title.

Review Committees Assist Medical Board



Additions to the Medical Practice Act in 1965 provided for the creation of five District Review Committees under the Board of Medical Examiners. DRC's hear disciplinary cases, which require medical knowledge, and recommend proposed decisions to the Board. Since 1967, District Review Committees have held over 132 disciplinary hearings.

Each committee represents a separate geographical area of the state and consists of five members. Committees review disciplinary cases in their designated area. Hearings are conducted according to the Adminis-

trative Procedure Act. Disciplinary actions are conducted by a hearing officer and are similar to proceedings in a court of law. The Board is represented by a deputy attorney general from the Department of Justice. Respondents may appear with or without counsel.

Recommendations of the District Review Committee are made in consultation with the hearing officer, and are sent to the Board for adoption, rejection or re-assignment back for further action.

Members of the DRC's are appointed to four-year terms by the Governor. Three members of each committee are appointed from nominations submitted by professional medical societies. One member of each committee is from the faculty of the clinical department of an approved medical school. The remaining member is appointed from nominations submitted by the Board of Medical Examiners.

**Physician's Assistants
Study Now Expanded**

Three Los Angeles-area colleges have been approved by the Board for training of Physician's Assistants in conjunction with the University of Southern California Medical Center. Cerritos College, Los Angeles City College and East Los Angeles Community College have been approved for P A programs. Earlier, the Charles R. Drew Postgraduate Medical School — UCLA, and Foothill College — Stanford University Hospital had been approved to conduct such programs.
