


The Senate Republican Leader has served in a number of key leadership positions within the Senate Republican Caucus, including Republican Caucus Chair

## DMV announces new CDL Medical Examination Guide

The California Department of Motor Vehicles (DMV) recently updated "A Physician Guide for Commercial Driver License Medical Exams." There are numerous changes that commercial driver medical examiners need to be aware of including changes to physical qualifications for drivers.

This booklet will be especially helpful if you:

- Conduct these exams infrequently.
- Encounter conditions that may be disqualifying and further explanation of the medical standard is needed.
- Have medical reports returned to your office by DMV because of errors or omissions.

In January 2012, a new version of the California Medical Examination Report (DL 51) was printed. Items were added that are mandated by Federal Motor Carrier Safety Regulations (FMCSR). Items added during the last revision were the driving type certification, medical examination effective dates, medical examiner license issue and expiration dates. Information concerning the new Federal National Registry of Certified Medical Examiners is also in the new guide. **Beginning May 21, 2014**, all Medical Examiners who wish to conduct medical examinations for interstate commercial drivers must complete training about the Federal Motor Carrier Safety Administration's (FMCSA) physical qualifications regulations and advisory criteria and pass a certification test to be listed on the National Registry.

Medical Examiners who would like an electronic PDF version of the new Physician Guide for Commercial Driver License Medical Exams may email the DMV from a medical business email account. ## YOU ASKED FOR IT

### Questions received from the Web

**Q. How long should a medical doctor keep a record of continuing medical education credits?**

A physician should keep proof of CME credits for four years in case he or she is audited by the Medical Board.



**Q. As a physician in solo practice, am I required to be certified in Cardiopulmonary Resuscitation (CPR) in order to renew my license?**

There is no statutory requirement for a physician to be certified in CPR for the renewal of the license with the Medical Board.

**Q. What is a physician's obligation regarding a death certificate?**

A death certificate is a legal document, and disposition of the remains cannot occur until the death certificate is filed with the Office of Vital Records and Statistics. The attending physician is required to complete and sign a death certificate within 15 hours of the natural death of his or her patient (unless the case is subject to coroner's inquiry). The physician is responsible for either providing the certificate to the hospital, delivering it to the funeral director, or arranging with the funeral director to pick it up at his or her office. If the attending physician is unavailable, a physician may designate another physician who has access to the physician's records and who is in consultation with the physician.

**Q. I recently renewed my license online, but I need a copy of my receipt. Please advise how I can get this.**

To view or print a receipt:

- 1) Log into the On-Line Professional Licensing System with the user id and password that you created at the time you initially went online to renew your license;
- 2) Select the "User Profile" link, located to the left side of the screen (gray navigation area).;
- 3) Select the "View Receipts" link. (IF YOUR COMPUTER HAS A POP-UP BLOCKER, PLEASE DISABLE BEFORE VIEWING.)
- 4) Select the "View Receipt" link if you wish to view a summary of the recent online transaction.
- 5) Select print on the computer to print the receipt.

## ***Responsible Opioid Prescribing: A Clinician's Guide – Second Edition now available***

The author of *Responsible Opioid Prescribing*, Scott M. Fishman, M.D., has recently published a second edition to his book – *Responsible Opioid Prescribing: A Clinician's Guide*. Dr. Fishman is a leading pain medicine clinician, researcher, teacher, lecturer, and writer. He is Chief of the Division of Pain Medicine and Professor of Anesthesiology at the University of California, Davis.

The revised and expanded *Clinician's Guide* translates best practice guidelines from leading pain medicine societies and the Federation of State Medical Boards into pragmatic steps for risk reduction and improved patient care, including:

- Patient evaluation, including risk assessment
- Treatment plans that incorporate functional goals
- Informed consent and prescribing agreements
- Periodic review and monitoring of patients
- Referral and patient management
- Documentation
- Compliance with state and federal law
- Patient education on safe use, storage and disposal of opioid medication
- Termination strategies for chronic opioid therapy



Since publication of the first edition in 2007, *Responsible Opioid Prescribing* has been widely used and supported in the medical and regulatory communities as the leading continuing medical education (CME) activity for prescribers of opioid medications.

Dr. Fishman has been board certified in Internal Medicine, Psychiatry, Hospice and Palliative Medicine, and Pain Medicine. He is the author of *The War on Pain and Listening to Pain*, coauthor of *Spinal Cord Stimulation*, and coeditor of *Bonica's Management of Pain and Essentials of Pain Medicine and Regional Anesthesia*.

## California State Board of Pharmacy Alert – New law takes effect

This is a reminder about a new law effective July 1, 2012 regarding the required elements for security forms for controlled substances.

Effective January 1, 2012, security prescription forms for controlled substances must include the preprinted address of the prescriber (Health & Safety Code § 11162.1). Security prescription forms that do not have the preprinted address of the prescriber can be filled and dispensed by the pharmacist until July 1, 2012. Prescription forms not in compliance are invalid and cannot be accepted on or after July 1, 2012.

Additionally, licensed health care facilities or clinics exempt under Section 1206 (those having 25 or more licensed physicians or surgeons preprinted on the form) are not required to preprint the category of licensure and license number of their facility or clinic (Health & Safety Code § 11162.1[c][2]).

## Finding Balance

**On September 20, 2011 we lost Lee Lipsenthal, M.D., a California physician and passionate advocate for physician wellness. This article and the series are dedicated to his work and vision.**

There is not a physician that more exemplified balance than Lee Lipsenthal. I first had the pleasure of meeting Lee at a Scripps Clinic conference about a decade ago. Lee was giving a lecture on stress management and he surely knew the topic based on his work with heart patients. Prior to coming to California he had been the Director of Cardiovascular Services for the Benjamin Franklin Clinic in Philadelphia. Once in California, he became the Medical Director of the Preventive Medicine Research Institute. The institute coordinated the Ornish Program for Reversing Heart Disease for which our clinic was one of the early clinical sites. Through his passion for a balanced approach to cardiac care, he tirelessly worked with the most Type A of patients, knowing that a comprehensive approach, which included stress management, had the best chance of preventing heart attacks and reducing costs.

Unfortunately, in his work with the many clinicians who were in the front lines of care, he realized that they were in as much need for balance as the patients in the program. He also realized that in helping these clinicians find balance, the care they provide would improve as well as bring them increased life and work satisfaction. He made the difficult choice to work upstream, and over time, Lee dedicated his career to the cause of clinician balance.

As he began this particular lecture, instead of a typical gloomy review of the state of physician stress and burnout, he helped the audience remember why they got into medicine and the little pleasures (for him it included music and baseball) that made life a joy. He was able to take a topic that sounded bleak and transition it into a picture of hope. Since that point, I have been an admirer and friend of Lee's. In a topic area with no blockbuster drugs or lucrative advisory boards, I saw him spend his time selflessly lecturing to med students, insurers, medical

groups and organizations (including the AAFP, AMA and Kaiser among many). Over time they became convinced of the crisis of physician burnout and the merits of clinician stress management and resiliency.

In most cases, like with me, he found converts in the audiences he spoke to. As he often did, he would provide encouragement (as well as slides if needed) to support those who would help him take the message to those most in need. With increased demand, he was able to collect his advice in a book called *Finding Balance in a Medical Life* which I would recommend to all readers as a key guide for finding balance.



He then went on to develop courses, included a Kaiser CME program on the topic as one of the nation's first on-line courses for clinician balance. As he said in the book, "I ... think of balance as the stability to ride the winds of change. To be successful and happy, one must be ready to catch the wind when it arises".

In July of 2009 at the age of 52, he was caught in a storm of change as he was diagnosed with metastatic esophageal cancer. After the diagnosis, instead of retreating, in typical Lee fashion, he decided there was no better time to find balance. So he put his soul into his last book and his greatest collection of wisdom, *Enjoy Every Sandwich; Living Each Day as if it Were Your Last*.<sup>2</sup> He asked himself, and his readers, important questions including *who and what are most important?* If you had just a few months to live what would you spend your time doing? He lived his answers by going on an international trip with his family and continued to speak to audiences. One of the last times I saw him was at the AAFP National Assembly in the fall of 2010. There during his keynote address, he remarked: "Balance is knowing that today is a good day to die; that you have lived fully, lovingly, and without remorse."

During the subsequent year, Lee continued to press on, inspiring everyone he knew that balance and gratitude can come at any time including during the last chapters of one's life. I was continually inspired by his composure and grace and have been able to tell his wife Kathy, also a physician, how lucky the world was to have Lee.

Lee provided many gifts to medicine and humanity including his instrumental work with the Ornish program, which in August of 2010 gained Medicare approval.<sup>3</sup> More importantly, he proved with his actions and intentions that balance and its key components, gratitude and acceptance, are possible at any moment, even the most difficult. So in the spirit of Lee's work, the MBC Newsletter is launching *Finding Balance*, an ongoing series on this topic. We will be exploring the causes and innovative solutions clinicians and clinics are using to find solutions for stress and burnout.

Let us know what has worked for you so we can continue the support of our colleagues at every stage of training and practice – as Lee would have endorsed. work as referenced below<sup>4</sup> and consider attending the Osler Symposium *"Doctoring in the 21st Century – Embracing the Challenge"* taking place October, 2012 in San Diego.<sup>5</sup> This conference is dedicated to Lee Lipsenthal and will feature the inaugural Lee Lipsenthal Lecture by Dean Ornish MD. In the meanwhile I hope that as Lee would have encouraged, you do your best to *enjoy every sandwich*.

## Summer sun – warn your patients about the dangers of UV rays

Summer is upon us, which means that many of our patients will be spending more time outdoors. Even if they're not sunbathing, warmer weather means that they'll be wearing less clothing and more of their skin will be exposed to UV rays. This is the ideal time to educate your patients about safer sun habits and to remind them that sun exposure not only leads to painful sunburns, but also skin cancer. For those patients who tell me that they're not afraid of getting skin cancer, I appeal to their vanity and explain that sun damage is also the cause of sun spots, dark splotches, rough skin, and wrinkles.

One group that deserves extra attention is young adults. My young adult patients tend to be the least concerned about the effects of sun exposure; but, I tell them that they should be the most worried. A recent study from the Mayo clinic showed a dramatic rise in melanoma, the deadliest type of skin cancer, among young Americans in their 20s and 30s over the past few decades. This rise is particularly alarming in young women, in whom the incidence of melanoma has increased eight-fold. In young men, the number of melanoma cases has increased four-fold. The researchers think this increase is due to the rise in tanning bed use. Hopefully, recent legislation against tanning beds will help slow this epidemic. In January of this year, California became the first state in the U.S. to ban all minors under the age of 18 from using tanning beds. (Texas previously banned those under 16.)

Tanning beds can be a hard habit to break. Studies have shown that the sun's rays stimulate reward centers in the brain, similar to the effect of other addictive substances. This is why it's important to reach tanning bed users as soon as possible. I also encourage them to switch to spray tanning and to use sun protection when they're outside.

Here are some simple guidelines for sun protection that I give my patients of all ages:

- Use a sunscreen with SPF 30-50. The FDA has found that sunscreens with SPF greater than 50 do not provide additional protection from sun damage or skin cancer. And, those with higher SPF are more likely to cause irritation and allergic reactions.
- Choose one that provides "broad spectrum" protection. This means that it protects against both UVA and UVB rays.
- Reapply every 3-4 hours, or sooner if you go in the water, sweat profusely, or are in a very humid climate.
- If you're in the water, or if you sweat profusely, try using a sunscreen stick, which is more water resistant and less likely to run into your eyes. Many children also prefer using a stick sunscreen, and those who won't sit still for a sunscreen cream will often find it fun to apply themselves
- Sun protecting clothing and swim shirts or "rash guards" are a good idea for water sports.
- Talk to your doctor about checking your vitamin D level, especially if you're diligent about sunscreen.
- Show your doctor if you see a new or changing spot or growth. If you see something new on someone's back or the back of their legs, point it out to them. You may be saving their life.

As I tell my patients, enjoy the outdoors this summer; just be sure to take care of your skin while you're out!

## Section 805 reporting – Not submitting is Costly

Physicians are among the “most trusted” group of people in this country, but they are human and humans as we know are fallible. Life and the pressure of running a practice can take a toll, something happens and suddenly a physician gets called in for a peer review and staff privileges are restricted or revoked. Now, the physician begins the process of repairing the wrong and working to satisfy the demands of his peers in hopes of getting his or her staff privileges restored. This, however is not the end of the story for a peer review body, there is the matter of filing an 805 report with the Medical Board of California (MBC). If you are not sure when an 805 report is required to be reported, you will want to read this article and study Business and Professions Code (B&P) §805 – Peer review; Reports.

B&P Code §805 describes the information that is required to be filed with the MBC and by whom, when a peer review body denies or terminates staff privileges, membership or employment, restricts privileges, or fails to renew or reestablish any staff privileges based on a medical disciplinary cause or reason. Once those staff privileges are restricted, denied or terminated, the clock starts ticking to report the action to the Board.

So, now you ask how soon and who has to file the 805 report? Fifteen (15) days is all the time there is to file the 805 report. B&P Code §805(7)(b) states: “The chief of staff of a medical or professional staff or other chief executive officer, medical director, or administrator of any peer review body and the chief executive officer or administrator of any licensed health care facility or clinic shall file an 805 report with the relevant agency within 15 days after the effective date...”.

Sometimes people mistakenly think an 805 report does not have to be filed if a physician is simply placed on restriction. This is not true. To clear up this misconception, the bulleted items that follow describe the situations when an 805 report must be filed, within 15 days from the date of action, as taken directly from the 805 fact sheet on the Medical

Board’s website at: [http://www.mbc.ca.gov/forms/805\\_factsheet.pdf](http://www.mbc.ca.gov/forms/805_factsheet.pdf).

- A peer review body denies or rejects a licensee’s applications for staff privileges or membership for a medical disciplinary cause or reason
- A licensee’s staff privileges, membership, or employment are revoked for a medical disciplinary cause or reason
- Restrictions are imposed, or voluntarily accepted, on staff privileges, membership, or employment for a total of 30 days or more within any 12 month period for medical disciplinary cause or reason
- An 805 report must be filed if the resignation, leave of absence, withdrawal or abandonment of application for or renewal of privileges occurs after receiving notice of a pending investigation initiated for a medical disciplinary cause or reason
- A summary suspension of staff privileges, membership, or employment is imposed for a period in excess of 14 days

So, what happens if the 805 report is not filed with the MBC? B&P Code §805 states that anyone who is designated or required by law to file the 805 report willfully fails to do so, that person can be fined up to \$100,000 per violation. But, what if it was a clerical snafu, an oversight, or it was lost in the mail? Things do happen. However, that is no excuse, and the fine in those cases can be up to \$50,000 per violation. Either way, this is serious money, and the 805 report is a serious matter.

The 805 report is not just about disciplinary matters; it applies to other situations too. For example:

- a) If a physician resigns or takes a leave of absence from membership, staff privileges or employment.
- b) The physician withdraws or abandons his or her application for staff privileges or membership.
- c) The physician withdraws or abandons his or her application for renewal of staff privileges or membership.

## Revisiting Informed Consent for Telehealth Services

*Recently, the Medical Board received an inquiry regarding informed consent and whose obligation it was to obtain the necessary consent from the patient who would be undergoing the medical procedure. Specifically, the question was whether physicians could delegate this task to another licensed health care provider or other personnel under their supervision. While the Board could find no statutory or regulatory bar to this proposed process, the Board suggests that public policy is best served when the physician performing the procedure secures the consent from the patient. In this manner, if the patient has questions or concerns, the physician is in the best position to address those matters. The following is provided as a reminder of the legal requirements when practicing medicine via telehealth:*

**Telehealth (previously called telemedicine) is seen as a tool in medical practice, not a separate form of medicine.** There are no legal prohibitions to using technology in the practice of medicine, as long as the practice is done by a California licensed physician. Telehealth is not a telephone conversation, e-mail/instant messaging conversation, or fax; it typically involves the application of videoconferencing or store-and-forward technology to provide or support health care delivery.

Business and Professions Code §2290.5 (b) states: “Prior to the delivery of health care via telehealth, the health care provider at the originating site shall verbally inform the patient that telehealth may be used and obtain verbal consent from the patient for this use. The verbal consent shall be documented in the patient’s medical record.”

**This is important:** Please note that the **standard of care** is the same whether the patient is seen in-person, through telehealth, or other methods of electronically enabled health care. The Medical Practice Act, including informed consent laws, applies in every area of medicine and in every practice setting and circumstance.

California laws pertaining to the use of telehealth should not be construed to alter the scope of practice of any health care provider or authorize the delivery of health care services in a setting, or in a manner, not otherwise authorized by law. Physicians need not reside in California, as long as they have a valid, current California license.

Then, an 805 report also must be filed and the same 15-day time limit applies as well.

So, if you restrict (for a total of 30 days within any 12-month period), deny or take away staff privileges, remember you have 15 days to submit the 805 report to the MBC, or be ready to get out the checkbook.

## **FDA** warns consumers about counterfeit version of Teva's Adderall

The U.S. Food and Drug Administration is warning consumers and health care professionals about a counterfeit version of Teva Pharmaceutical Industries' Adderall 30 milligram tablets that is being purchased on the Internet. Adderall, which is approved to treat attention deficit hyperactivity disorders (ADHD) and narcolepsy, is a prescription drug classified as a controlled substance – a class of drugs for which special controls are required for dispensing by pharmacists.

FDA's preliminary laboratory tests revealed that the counterfeit version of Teva's Adderall 30 mg tablets contained the wrong active ingredients. Adderall contains four active ingredients – dextroamphetamine saccharate, amphetamine aspartate, dextroamphetamine sulfate, and amphetamine sulfate. Instead of these active ingredients, the counterfeit product contained tramadol and acetaminophen, which are ingredients in medicines used to treat acute pain.

Currently on the FDA's drug shortage list, Adderall is in short supply due to active pharmaceutical ingredient supply issues. Teva continues to release product as it becomes available. Consumers should be extra cautious when buying their medicines from online sources. Rogue

websites and distributors may especially target medicines in short supply for counterfeiting.

The counterfeit Adderall tablets are white, round, and do not have any type of markings, such as letters or numbers. Any product that resembles the tablets or the packaging, in the photos found in the link provided below, and claims to be Teva's Adderall 30 mg tablets should be considered counterfeit. The counterfeit versions of Adderall should be considered as unsafe, ineffective and potentially harmful.

Authentic Adderall 30 mg tablets produced by Teva are round, orange/peach, and scored tablets with "dp" embossed on one side and "30" on the other side of the tablet. Teva's Adderall 30 mg tablets are packaged only in a 100-count bottle with the National Drug Code (NDC) 0555-0768-02 listed.

## **Counterfeit version of Avastin in U.S. distribution**

### ***FDA sends letters to over 40 medical practices about counterfeit product and other unapproved cancer medicines***

The U.S. Food and Drug Administration is warning health care professionals and patients about a counterfeit version of Avastin 400mg/16mL, which may have been purchased and used by some medical practices in the United States. Avastin is an injectable medicine used to treat cancer and is administered to patients in clinics, hospitals, and other doctors' offices. The counterfeit version of Avastin does not contain the medicine's active ingredient, bevacizumab, which may have resulted in patients not receiving needed therapy.

In a related action, the FDA has issued letters to more than 40 medical practices in California that purchased unapproved cancer medicines that may include the counterfeit Avastin. The counterfeit version is labeled as Avastin, manufactured by Roche. Roche is the company that manufactures Avastin approved for marketing outside of the United States. ## **“Patient-Centered” Prescription Labels Now Required – Bigger is better**

California’s new prescription label requirements (Business and Professions Code §4076.5) stipulate that all pharmacists, physicians and others who dispense prescription medications must modify their prescription container labels to make them easier for patients to read and understand.

The new format was designed to help reduce the incidence of medical errors, which represent a significant public health problem. Medication errors are reported to affect more than 150,000 California residents each year and cost the state an estimated \$17.7 billion annually.

To address the issue, a state panel of elected officials, health professionals, and community members convened in 2006 to study the problem and recommend solutions, as called for by SB 472 (Corbett, 2006), also known as the California Patient Medication Safety Act. Prescription drug labels were identified as an area where improvements were needed — it is estimated that almost half of American adults cannot understand the label on their prescription drug containers.

In response, the California State Board of Pharmacy gathered extensive research, solicited feedback from experts in the field of health literacy and conducted

a comprehensive consumer survey to develop guidelines for new, patient-centered labels. The guidelines stipulate that the label must prominently display information of greatest importance to patients, including:

1. patient name
2. name of the drug and strength
3. directions for use
4. purpose or condition, if included on the prescription document by the prescriber.

Fifty percent of the label must be dedicated solely to these elements and must be printed in at least a 10-point sans serif font. The patient may also request a 12-point sans serif font for easier readability. For added emphasis, the label must also highlight in bold typeface or color, or use blank space to set off the items listed above. All other information required on the label is to be placed in the remaining portion of the label.

## **Dark Chocolate May Be Cost Effective in Lowering Cardiovascular Risk**

Who says medicine has to taste bad to be good?

Dark chocolate may be a cost effective — and palatable — option to reduce cardiovascular risk in high-risk patients, according to a BMJ study. To construct their model, Australian researchers used data from meta-analyses that showed dark chocolate consumption reduced systolic blood pressure by 3.2 mm Hg and LDL cholesterol by 0.15 mmol/L (roughly 6 mg/dL). The model included 2000 people with hypertension and metabolic syndrome who were free of cardiovascular disease.

They calculated that over a decade, regular dark chocolate consumption could prevent 70 nonfatal cardiovascular events and 15 cardiovascular-related deaths per 10,000 population treated. The strategy would be cost effective if \$42 was spent per person per year on a dark chocolate prevention strategy (e.g., advertising, educational campaigns, or chocolate subsidies). The strategy would still be cost effective with only 80% compliance.

The authors conclude: “Chocolate benefits from being by and large a pleasant, and hence sustainable, treatment option. Evidence to date suggests that the chocolate would need to be dark and of at least 60-70% cocoa, or formulated to be enriched with polyphenols.”



#### **Tech Med Corner - Malware Infection Warning**

The Medical Board has received a warning about a malware computer infection that can take control of your computer domain name system (DNS) and redirect Internet requests away from your computer system to rogue servers. A group of seven eastern European computer criminals was arrested in November, 2011 and charged with engaging in wire fraud in connection with this infection. The malware is so sophisticated that millions of computers and systems have been infected and the owners have no idea. If left unchecked, you could lose connectivity to the Internet, however there is a way to determine if you have been infected. Users should follow these easy steps to clean their computers infected with the DNSChanger:

1. **Home Users:** Check to see if you are affected by visiting the following DNSChanger Test Site: [www.dns-ok.us](http://www.dns-ok.us)
2. If you are not affected by DNSChanger, no further action is required.
3. If the site indicates that you are affected, visit [www.dcwg.org](http://www.dcwg.org) for information on how to address this problem. After following the clean-up advice, check back with one of the test sites above.

**Traffic destined for these IP addresses may indicate DNSChanger or other malware infections.**

The aforementioned methods are the best way to determine if computers on your network are relying on the DNSChanger Clean DNS Servers.

## Explanation of disciplinary language and actions

**“Effective date of decision”** — Example: “March 14, 2012” at the bottom of the summary means the date the disciplinary decision goes into operation.

**“Gross negligence”** — An extreme deviation from the standard of practice.

**“Incompetence”** — Lack of knowledge or skills in discharging professional obligations.

**“Judicial review pending”** — The disciplinary decision is being challenged through the court system, i.e., Superior Court, Court of Appeal, or State Supreme Court. The discipline is currently in effect.

**“Probationary License”** — A conditional license issued to an applicant on

probationary terms and conditions.

This is done when good cause exists for denial of the license application.

**“Public Letter of Reprimand”** — A lesser form of discipline that can be negotiated for minor violations, usually before the filing of formal charges (Accusations). The licensee is disciplined in the form of a public letter.

**“Revoked”** — The license is canceled, voided, annulled, rescinded. The right to practice is ended.

**“Revoked, stayed, five years probation on terms and conditions, including 60 days suspension”** — “Stayed” means the revocation is postponed. Professional practice may continue so long as the

licensee complies with specified probationary terms and conditions, which, in this example, includes 60 days of actual suspension from practice. Violation of probation may result in the revocation that was postponed.

**“Stipulated Decision”** — A form of plea bargaining. The case is formally negotiated and settled prior to trial.

**“Surrender”** — To resolve a disciplinary action, the licensee has given up his or her license — subject to acceptance by the Board.

**“Suspension from practice”** — The licensee is prohibited from practicing for a specific period of time.
