#### PROGRAM UPDATE:

The Licensing Program continues to work diligently to meet weekly goals and to ensure licenses are issued promptly. Over the last fiscal year, the Board consistently accomplished weekly goals with no overtime. This is a remarkable accomplishment as this is the first time with no overtime for application reviews in many years. The Licensing Program continues to create and update existing procedures to ensure all tasks are completed in the most efficient manner.

During this quarter, the Licensing Program successfully made it through our busiest time of year when many residents training in California required a medical license by the end of June. Over this time period, the Board collaborated with many Graduate Medical Education Coordinators to establish a spreadsheet of applicants that needed to be licensed by the end of June. The management team and staff continued to manage the list to ensure the Board expedited all application reviews and incoming mail for those residents. In addition, the Board expedited the initial review and mail for applicant's needing licensure to begin a fellowship in California in July and for international medical school graduates needing a Postgraduate Training Authorization Letter (PTAL) to commence postgraduate training in California in July.

The Licensing Program's strategic goal for reviewing Physician's and Surgeon's License and PTAL applications has remained under the 45 day review time since May of 2016. Licensing staff has continued to exceed this goal for the fourth quarter of Fiscal Year 2016/2017 and has maintained a review time of 30 days or under since November of 2016. During the fourth quarter, the average number of days to complete the initial review of a Physician's and Surgeon's License and PTAL applications is 28 days. In addition, licensing staff continues to process all incoming mail within an average of seven days.

The Licensing Program has issued 6,805 medical licenses for the Fiscal Year 2016/2017. This is an increase of 489 medical licenses compared to Fiscal Year 2015/2016.

A detailed listing of the Licensing Program's statistics is included following this report.

#### **STAFFING:**

The Licensing Program has recently hired a Staff Services Analyst for the international medical graduate application review, a Management Services Technician for the United States/Canada graduate application review, and an Office Technician for the Cashiering Unit.

The Licensing Program is actively recruiting for five positions: Staff Services Analyst for the international medical graduate application review, Management Services Technician for the

United States/Canada graduate application review, Program Technician II for the Consumer Information Unit, an Office Assistant for the Cashiering Unit, and an Office Technician for licensing support.

### CONSUMER INFORMATION UNIT:

The Consumer Information Unit (CIU) staff maintains efforts to respond to a continually evolving environment by updating and developing training manuals and dialogue outlines. By defining call categories and mechanisms for directing conversation, staff are learning to handle each call more efficiently and continue to strive for exceptional customer service.

The Board's public greeting on the main line has been updated to ensure the callers are provided the most up-to-date information, receive answers to common questions, and informs callers how they can obtain specific information from the website.

The number of calls answered this quarter was 19,356 compared to 19,516 last quarter. The number of callbacks made by staff this quarter is 7,944, which is the highest compared to all quarters for FY 2016-2017.

### SPECIALTY BOARD APPLICATIONS:

The Board has two pending application from a specialty board requesting approval by the Board.

### **INTERNATIONAL MEDICAL SCHOOLS:**

The Licensing Program has six Self-Assessment Reports pending. Specifically, three are pending additional information from the medical school; two reports are with a medical consultant for review and recommendation; and one will be presented to the full board for recognition. As reported at the last Board meeting, staff identified 83 international medical schools that have failed to respond to Board's initial letter and follow-up requests for additional information to continue with the review process to recognize their school in California. Board staff continues to reach out to the medical schools in an attempt to obtain the necessary documentation to continue with the review process. If no response is received by July 15, 2017, their file will be closed and no longer in a pending status.

The Board has recently hired two Medical Consultants to assist with the review of international medical schools that wish to be recognized in California.
