Public Documents - What Can and Cannot Be Posted on a Licensee Profile



#### **Public Disclosure Laws**

- Business and Professions Code sections 2027 and 2221.05 determine what information can be posted on a licensee's profile
- Business and Professions Code section 803.1 explains what information is available to the public upon inquiry
- 16 CCR sections 1354.5 and 1364.15 further clarify information disclosure requirements

Available via Enforcement Public Document Search on the website unless suspension has been lifted by the Medical Board.
INTERIM SUSPENSION ORDER (ISO) (licensee's practice has been temporarily suspended or restricted by an Administrative Law Judge (ALJ)).	Date issued by an ALJ.	Available indefinitely.	Pursunt to B&P 2027, available on physician's profile only during period when physician's profile only during period when physician's license is suspended or restricted, deleted from profile if suspension or restriction is lifted or if an administrative decision becomes effective. Available via Enforcement Public Document Search on the website unless suspension or restriction has been lifted by the Medical Board.
OUT-OF-STATE AUTOMATIC SUSPENSION ORDER (R&P 2310) (licensee's practice in California is automatically suspended per notification of suspension or revocation of license in another state).	Date issued by Medical Board.	Available indefinitely.	Pursuant to B&P 2027, available on physician's profile only during period when physician's license is suspended; deleted from profile if suspension is littled or if an administrative decision becomes effective. Available via Enforcement Public Document Search on the website unless suspension has been liftled by the Medical Board.



The Board has a guidance document on the website that explains what information is available, how it can be obtained, and applicable laws.

#### **Public Disclosure Laws**

- Suspension/Restriction Orders available on the profile while the licensee is under the suspension/restriction and then is removed, but available indefinitely at the Board, as it is a public document.
- Accusation/Petition to Revoke Probation available on the profile until disposition. Unless the document is withdrawn, it becomes a part of the disciplinary document and follows that document's disclosure requirement.
- Accusation withdrawn immediately removed from the profile, but available for one year at the Board.


#### **Public Disclosure Laws**

- Accusation dismissed immediately removed from the profile, but available indefinitely at the Board, as it is a public document.
- Disciplinary action:
  - Revocation, surrender, probation available on the profile indefinitely.
  - Public Reprimand/Public Letter of Reprimand available on the profile for 10 years, but available indefinitely at the Board, as it is a public document.

#### **Public Disclosure Laws**

- Administrative action:
  - > Probationary License issued available on the profile while the individual is on probation, but available indefinitely at the Board, as it is a public document.
  - Citation Order available three years from the date it is resolved (if withdrawn or dismissed not available), then no longer public.
  - Public Letter of Reprimand issued at the time of licensure available on the website for three years, then no longer public.
