# **REQUESTED ACTION:**

This report is intended to provide the Members with an update on the Licensing Program at the Medical Board of California (Board).

### PROGRAM UPDATE:

The Licensing Program continues to offer staff overtime and focus on filling vacancies to help reduce the high processing time for reviewing initial license applications, which is currently on average 84 days, from the time the application is received to the time it is initially reviewed by staff. The number of applications received in Quarter 1 of FY 2022-2023 decreased from the previous quarter, which will also help reduce the application processing time. For Quarter 1 of Fiscal Year 2022-2023, the Board received 2,073 initial license applications (1,228 Physician's and Surgeon's (P&S) Initial License and Transition applications; 845 Postgraduate Training License (PTL) applications) and issued a total of 3,497 licenses (2,564 P&S licenses and 933 PTLs). Since the law changed on January 1, 2022, the Board has received 9,300 initial license applications through September 30, 2022, which is a 44% increase for the same time period in 2021. From January through June of 2022, the Board received 71% more initial license applications than the same time period in the 2021.

Beginning December 30, 2022, the Board will no longer provide paper applications for the Postgraduate Training License and the Transition from a PTL to a P&S License applications. Beginning February 1, 2023, the Board will no longer accept and process paper applications for these two application types submitted to the Board. In early 2023, the Licensing Program will make the same transition with the P&S License application from non-PTL holders. While medical schools and postgraduate training programs can submit all required documents through the Board's DOCS portal, the Licensing Program will continue to work with the Board's Information Systems Branch to further streamline processes for receiving documents from third-party entities.

### COVID-19 Waiver Update

Pursuant to the Governor's Executive Order N-39-20, during the State of Emergency, the Director of the California Department of Consumer Affairs may waive any statutory or regulatory professional licensing and training requirements pertaining to individuals licensed pursuant to Division 2 of the Business and Professions Code.

On September 29, 2022, the DCA Director issued a waiver to extend the deadline for specific individuals to obtain a Physician's and Surgeon's License. For P&S License applicants who received credit for 12 months of approved postgraduate training in another state or Canada, were accepted into an approved postgraduate training program in California, and are required to obtain their physician's and surgeon's license

on or before October 31, 2022, the waiver extended this deadline to November 30, 2022.

For PTL holders whose license expires on or before October 31, 2022 and received either 12 months credit of board-approved postgraduate training for graduates of medical schools in the United States and Canada, or 24 months credit of boardapproved postgraduate training for graduates of other foreign medical schools approved by the board, the waiver extended this deadline to November 30, 2022.

For individuals enrolled in a California board-approved postgraduate training program and are required to obtain a postgraduate training license on or before December 31, 2022, the waiver extended this deadline to January 31, 2023.

#### MEXICO PILOT PROGRAM (MPP)

As of September 2022, the Board has issued 21 licenses to MPP participants. Only one applicant is pending submittal of their visa application before requesting the Board issue their license.

Ten of the twenty-two physicians are currently practicing at Clinica de Salud del Valle de Salinas (CSVS) in Monterey County. Three are practicing at San Benito Health Foundation in San Benito County; and three are practicing at Altura Centers for Health in Tulare County.

The MPP program is anticipating a second cohort of eight applicants to fulfill the remaining 30 positions authorized in statute. These eight applicants are currently participating in the required six-month program orientation in Mexico and the required ESL coursework while simultaneously working on their license application and visa application. This should streamline the process to allow the Board to issue the licenses within a shorter timetable than the first group of applicants. The eight new physician applicants are anticipated to be licensed by March 2023.

In August 2022, the University of California, Davis, published the 1<sup>st</sup> Annual Progress Report of the MPP and presented the report to the Board at its August 2022 meeting. The goal of the evaluation is to make recommendations on whether the pilot should be continued, expanded, altered, or terminated. This recommendation will be based on six (6) broadly defined, multidimensional, outcomes: Quality of Care, Adaptability of Physicians, Impact on Working and Administrative Environment, Patient Experience, Impact on Culturally and Linguistically Appropriate Services (CLASP, and the Impact on Limited English-Speaking Patient Encounters. UC Davis anticipates completing the evaluation by 2025 upon conclusion of the MPP program.

On August 5,2022, CSVS hosted Senator Ana Caballero; Secretary Lourdes Castro Ramirez; Mr. Arnoldo Torres; the CEOs of the four participating community health centers; seven MPP physicians participating at CSVS; CSVS Board members; Monterey County Supervisor, District 4; Department of Consumer Affairs; and the Medical Board of California to an MPP Roundtable Discussion. At the roundtable, attendees had the opportunity to hear from the licensees and their experience in the program. Roundtable discussions covered what is going well with the program; the challenges; how the state can better support the physicians' work; and positive feedback was shared from CSVS about the impact MPP physicians are making in the communities they are serving throughout Monterey County.

### WEBMASTER

The Licensing Program received 4,186 emails and responded to 4,206 via the Licensing Webmaster in Quarter 1 of the current fiscal year regarding topics, such as application status checks, PTL expiration date extensions, and license renewals.

### CONSUMER INFORMATION UNIT

In Quarter 1 of FY 2022-2023, the Consumer Information Unit (CIU) received 21,676 calls, with an average wait time of 24:05 minutes. Five of the topics most responded to in CIU during this quarter were application status checks, physician and surgeon application questions, complaint questions, pocket licenses, and renewal questions. The Licensing Program is in the process of recruiting for two (2) Program Technician IIs and recently hired a Supervising Program Technician II. The Licensing Program staff and other Board units continue to assist CIU to help minimize wait times.

### <u>OUTREACH</u>

The Licensing Program conducted seven outreach presentations in Quarter 1. The presentations covered license requirement changes and the application process and were provided to the following groups: San Mateo County Behavioral Health and Recovery Services; University of California, Irvine; the University of Southern California and Los Angeles County Medical Center; Kaiser, Los Angeles; University of California San Francisco; University of California, Fresno; and Kern Medical, Bakersfield. Due to COVID safety measures and to reduce travel expenses, most of the outreach presentations have been conducted virtually. Future outreach events will include information on transitioning to a full paperless process.




## Physician's and Surgeon's Licenses Issued\* Four Fiscal Year History

# Postgraduate Training Licenses Issued\* Fiscal Year History







