Agenda Item 1 Call to Order/Roll Call/Establishment of a Quorum

Dr. Healzer called the meeting of the Special Faculty Permit Review Committee (Committee) of the Medical Board of California (Board) to order on March 5, 2025, at 10:11 a.m. A quorum was established. Dr. Healzer welcomed new members to the committee: Ms. Anni Chung, Public Member of the Board & Vice chair of the Committee, Dr. Rajesh Gulati representing UC Riverside, Dr. Jennifer Gullo representing California Northstate University, Dr. Emily Lukacz representing UC San Diego, Dr. Pedro Tanaka representing Stanford University.

Agenda Item 3 Approval of the Minutes from the December 6, 2023, Special Faculty Permit Review Committee Meeting

Agenda Item 4 Application Presentation and Discussion

Dr. Lum presented Somnath Chattopadhyay's application for a Special Faculty Permit (SFP) at Loma Linda University School of Medicine pursuant to Business and Professions Code (BPC) section 2168.1. Dr. Gewertz inquired whether Dr. Chattopadhyay had any prior clinical practice in the U.S., such as through a fellowship or observership. Dr. Lum responded that Dr. Chattopadhyay completed a two-year American Society of Transplant Surgeons-approved abdominal transplant fellowship at the University of Pennsylvania. It was a standard fellowship but notably demanding due to a shortage of transplant staff, which resulted in Dr. Chattopadhyay performing a higher-than-average number of procedures. During his fellowship, he independently performed kidney transplants and served as the primary surgeon for hepatic-portal vein anastomosis in other transplant procedures. There were no public comments for this application.

Dr. Gewertz presented Dr. Alexandre Gaston Michael Lellouch's application for an SFP at Cedars-Sinai Medical Center pursuant to BPC section 2168.1. There were no questions or comments from the Committee members. There were no public comments for this application.

Open session paused at 10:29 a.m. and the Committee reconvened in the Closed Session, pursuant to Government Code section 11126(c)(2), for deliberations under Agenda Item 5.
