#### REQUESTED ACTION:

Review the Special Faculty Permit Review Committee's (Committee) recommendation for a Special Faculty Permit (SFP) appointment for Mohammad Pakravan, M.D., pursuant to California Business and Professions Code (BPC) section 2168.1(a)(1)(B).

#### BACKGROUND

The Medical Board of California (Board) is authorized to issue an SFP to a physician who is academically eminent and meets all the requirements pursuant to BPC section 2168.1.

The SFP authorizes an individual to practice medicine only within the medical school and its affiliated institutions where the SFP holder is providing instruction as part of the medical school's educational program, and for which the medical school has assumed direct responsibility.

The Committee is comprised of 14 members: one representative from each of the 11 medical schools in California, one representative from academic medical centers, and two Board members. The Committee reviews and makes recommendations to the Board regarding the eligibility of the applicants applying pursuant to BPC section 2168.1(a)(1)(B).

On June 11, 2025, the Committee reviewed the qualifications of an applicant from Loma Linda University School of Medicine (LLU): Dr. Pakravan. Committee member Dr. Daniel Giang presented Dr. Pakravan's qualifications for an SFP to the Committee.

Dr. Pakravan is an academically eminent and internationally recognized expert in the field of glaucoma. He possesses a diverse surgical skill set, including trabeculectomy and Microincision Glaucoma Surgeries, which will offer Loma Linda patients more treatment options for uncontrolled glaucoma than are currently available. He has authored over 100 publications. From 2012 to 2019, he served as the Glaucoma section head at Shahid Beheshti University. He currently serves as an associate professor at the University of Texas Medical Branch Department of Ophthalmology.

Dr. Pakravan's expertise will greatly benefit the population of the Inland Empire, which is an underserved population. LLU Eye Institute manages tertiary referrals of glaucoma patients in the region. While the LLU Eye Institute previously had three full-time glaucoma specialists, it now only has one. Recruitment has been difficult, and there is a critical need for glaucoma surgeons. Bringing Dr. Pakravan in will lessen the strain on the one remaining full-time doctor and comprehensive ophthalmologists, as well as provide more treatment options for patients.

LLU recruited Dr. Pakravan for the position of Associate Professor in the Department of Ophthalmology.

He will also share emergency glaucoma on-call coverage, serve on the comprehensive on-call coverage panel, and assist with the LLU Hospital inpatient consultation service. Additionally, he will continue his scholarly activities, including clinical research and teaching of medical students and residents.

#### **REQUESTED ACTION:**

Review the Special Faculty Permit Review Committee's (Committee) recommendation to the Medical Board of California (Board) to approve a request from the University of California Davis School of Medicine (UC Davis) to appoint Special Faculty Permit (SFP) holder, Hatice Kader Karli Oğuz, M.D., to division chair of Neuroradiology in the Department of Radiology at UC Davis.

#### **BACKGROUND:**

The Medical Board of California (Board) is authorized to issue an SFP to a physician who is academically eminent and meets all the requirements pursuant to BPC section 2168.1. Additionally, in accordance with BPC section 2168(c), a medical school or academic medical center must obtain written authorization from the Board to appoint an SFP holder to a position as a division chief or head of a department.

The SFP authorizes an individual to practice medicine only within the medical school and its affiliated institutions where the SFP holder is providing instruction as part of the medical school's educational program, and for which the medical school has assumed direct responsibility.

The Committee is comprised of 14 members: one representative from each of the 11 medical schools in California, one representative from academic medical centers, and two Board members. The Committee reviews and makes recommendations to the Board regarding the eligibility of the applicants applying pursuant to BPC section 2168(c).

Dr. Karli Oğuz was issued SFP 48 at UC Davis on February 2, 2023. SFP 48 is current, in good standing, and expires February 28, 2027. On May 15, 2025, the Board received a request from UC Davis to approve the appointment of Dr. Karli Oğuz to division chief of neuroradiology in the Department of Radiology at UC Davis.

On July 30, 2025, the Committee reviewed the qualifications of Dr. Karli Oğuz. Dr. Reginald Low, an interventional cardiologist at UC Davis, and a previous Board and Committee member, presented Dr. Karli Oğuz's qualifications to the Committee on behalf of Committee member Dr. Susan Guralnick, who could not attend the meeting.

Dr. Karli Oğuz is internationally recognized for her clinical and research expertise in neuroradiology and pediatric neuroradiology. Her areas of expertise include imaging of epilepsy, autoimmune diseases, neurodegenerative and inherited metabolic diseases, and brain tumors. Elizabeth A. Morris, M.D., Professor and Chair of the Department of Radiology at UC Davis, is recommending Dr. Karli Oğuz's appointment as division chief of neuroradiology in the Department of Radiology based on her extensive body of work and outstanding clinical competence and leadership abilities shown in her current position at UC Davis.

#### **REQUESTED ACTION:**

Dr. Jayasundera is internationally and nationally recognized for his expertise in inherited retinal diseases. He has been certified by the Royal Australian and New Zealand College of Ophthalmologists and is certified by the American Board of Ophthalmology. Dr. Jayasundera has extensive experience in diseases of the retina and vitreous, diagnosis and treatment of inherited retinal degenerative diseases, and the management of inflammatory diseases. He is a tenured professor in the Department of Ophthalmology and Visual Sciences at the University of Michigan in Ann Arbor. He also serves as the associate chair of Strategic Planning and director of the Inherited Retinal Diseases Program at the Kellog Eye Institute.

Dr. Jayasundera holds an R01 grant to study expression of inherited retinal diseases. As an active researcher, he has authored over 100 peer-reviewed articles, as well as one author reply, one book, one book chapter, and 79 abstracts/poster presentations.

UC Davis recruited Dr. Jayasundera for the position of chair and professor in the Department of Ophthalmology, and director of the Ernest E. Tschannen Eye Institute.
