Meeting Information

Pursuant to Business and Professions Code (B&P) section 2525.1, the Medical Board of California (Board) is authorized to develop and adopt medical guidelines for the appropriate administration and use of medical cannabis. In 2004, prior to B&P section 2525.1 becoming law, the Board adopted a statement to provide guidance to physicians regarding recommending marijuana to patients. This statement was amended by the Board in October 2014. With the addition of B&P section 2525.1, the Board will be reviewing its current statement and making any necessary amendments to its existing statement. The intention of the guidelines is to provide physicians guidance when evaluating a patient and providing a recommendation for marijuana in order to ensure the standard of care is followed.

The purpose of the Marijuana Task Force (Task Force) is to receive information and input from interested parties on revisions to the Board's current statement. In order to conduct a successful meeting in the time allotted, any interested party may notify the Board they will be attending and provide written materials for the Task Force to consider. The submission of materials prior to the meeting is encouraged, but voluntary, to allow the Task Force Members time to review the materials prior to the meeting. The Task Force does not intend to discuss physicians' use of marijuana at this meeting. The Board relies on B&P sections 822 and 2239, among other applicable codes and regulations, to take appropriate action if it receives a complaint about physician impairment.
