STLRP Funding

- STLRP receives funding from a variety of sources
 - Medically Underserved Account for Physicians: fund that is comprised of physician licensure renewal fees from the Medical Board of California and the Osteopathic Board and fines and penalty fees from the Department of Managed Healthcare.
 - State General Fund mental health workforce investment funds for mental health professionals.
 - Health plan mergers: CVS/Aetna: \$5,600,000, and Cigna/Express Scripts: \$1,500,000
 - With the additional investments beyond the regular funding from the license fees, we expect to have a similar funding amount as we did in FY 2019-20, around \$12 million.

- Maximum award amount for each STLRP award is \$105,000. Not all awards will be funded at the maximum award amount as awards amounts are based on the educational debt still owed.
