



## Legislative Update

### Board-sponsored restructuring

#### AB 253 (Eng, Chapter 678)

##### Restructuring of the Medical Board of California

Combines the two divisions of the board into one board on January 1, 2008. Revises the decision-making authority of the board by allowing the board to delegate to the executive director the authority to adopt default decisions and stipulations to surrender a license in disciplinary proceedings. Reduces the board membership from 21 members (12 physician members and nine public members) to 15 members (eight physician members and seven public members), effective January 1, 2008 to 17 members, and, on August 1, 2008 to 15 members.

### Chapters legislation

#### AB 3 (Bass, Chapter 376)

##### Physician Assistants

Allows a physician assistant to administer, provide, or issue a drug order under general protocols for Schedule II through Schedule V controlled substances without advanced approval by a supervising physician for each specific patient if the physician assistant completes specified educational requirements. Increases the number of physician assistants a physician may supervise from two to four (making this consistent with the number supervised in underserved areas). Specifies the services provided by a physician assistant are included as a covered benefit under the Medi-Cal program.

#### AB 329 (Nakanishi, Chapter 386)

##### Chronic Diseases: Telemedicine

Allows the Medical Board to establish a telemedicine pilot program. Authorizes the board to implement the program by convening a working group of interested parties. The board is required to make recommendations to the Legislature within one calendar year of the commencement date of the pilot program.

#### AB 682 (Berg, Chapter 550)

##### HIV/AIDS Testing

Deletes the provisions that prohibit testing a person's blood for evidence of antibodies acquired immunodeficiency syndrome

(AIDS) without written consent of the subject. Instead, requires a medical care provider, prior to ordering a test that identifies infection with human immunodeficiency virus (HIV), to inform the patient that the test is planned, provide information about the test, inform the patient regarding specified treatment options, and advise the patient that he or she has the right to decline the test. Requires that the person engaged in prenatal care of a pregnant woman ensure follow-up care for the mother and infant should the mother test positive for HIV antibodies. Strongly encourages providers to seek consultation with specialists who provide care for these women and their infants.

#### AB 1073 (Nava, Chapter 621)

##### Workers' Compensation: medical treatment utilization schedule

Makes changes in the Workers' Compensation law that will benefit injured workers. Provides that the current limit of 24 visits for chiropractic, occupational therapy, and physical therapy shall not apply to visits for post-surgical physical medicine and rehabilitation services.

## The mission of the Medical Board of California

The mission of the Medical Board of California is to protect healthcare consumers through proper licensing and regulation of physicians and surgeons and certain allied healthcare professions and through the vigorous, objective enforcement of the Medical Practice Act, and, to promote access to quality medical care through the board's licensing and regulatory functions.

# President's Report

Throughout the first decades of California's union, growth and development were largely confined to the northern part of the state. Good doctors were rare and medicine was practiced by a variety of healers, unchecked in their theories, methods, and prices. From 1850 to 1870, there was a migration to southern California of thousands and then tens of thousands of invalids yearning for a healthy, dry climate. The migration of health seekers was accompanied by a migration of doctors.

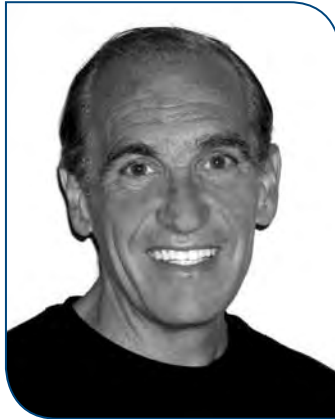
The evolution of the Medical Board of California began when the Legislature passed the first Medical Practice Act in 1876 and a Board of Examiners was established consisting of seven members. After conflicts over representation, power of appointment, and jurisdiction of the Board, the Legislature revised the Medical Practice Act in 1878 to provide for three separate Boards of Examiners: a State Medical Society Board, an Eclectic Medical Society Board, and a Board elected by the Homeopathic Medical Society.

The lack of funds severely restricted the Boards' abilities to regulate the quality of medical practice and in 1901, the Legislature repealed all prior Medical Practice Acts and enacted a new law consolidating the three boards into one nine-member Board. Only this new Board of Examiners could grant the right to practice medicine in California, and then only to those physicians passing a written examination.

Through the years, the Board has experienced several changes in its name, changes in the membership ratio of physicians to public members, and changes in its mission and responsibilities to both the consumer and the physician.

In December 1975, the Medical Injury Compensation Reform Act was passed, changing in 1976 the Board of Medical Examiners to the Board of Medical Quality Assurance; increasing the membership of the Board from 10 physicians and one public member to 12 physicians and seven public members. The new 19-member Board was comprised of three sections: the Division of Medical Quality, the Division of Licensing, and the Division of Allied Health Professions (the latter Division was abolished in 1994).

The responsibilities of the Division of Medical Quality included reviewing the quality of medical practice of physicians under the jurisdiction of the Board; administering

discipline of physicians found to violate the laws or regulations, and carrying out disciplinary action appropriate to findings made by a Medical Quality Review Committee, an administrative law judge, or the Division.

The responsibilities of the Division of Licensing were to develop and administer the physician and surgeon examinations; issue licenses and certificates to physicians and other allied health care professionals, including midwives, registered dispensing opticians, registered contact lens dispensers, etc.; conduct site visits at medical schools

and teaching hospitals as part of its Special Programs oversight responsibilities; administer the special faculty permits; administer a program of continuing education for certificate holders; approve undergraduate and graduate medical education programs; approve clinical clerkships and special internship programs; and administer student loan programs and grants. More recently, and spirited by legislation, a Cultural and Linguistic Physician Competency Program Workgroup has been created to educate physicians on other cultures and languages that impact their patient health care practices.

Each Division had certain responsibilities as listed above and was prohibited from delegating its authority to the other. The Board did not have the authority to move members from Division to Division for educational purposes or when quorums were an issue.

Fast forward to present time and Assembly Bill 253 (Eng, 2007). This bill, which became effective January 1, 2008, eliminates the Division of Licensing and the Division of Medical Quality, and provides for the Board as a whole to handle the responsibilities of the divisions; revises the decision-making authority of the Board by allowing the Board to delegate to the executive director the authority to adopt default decisions and stipulations to surrender a license in disciplinary proceedings; and reduces the Board membership from 21 members (12 physician members and nine public members) to 15 members (eight physician members and seven public members). This is consistent with the Board's review of its workload, membership and other needs, but is subject to review and possible changes.

# Preventive medicine and the seven deadly sins: avoiding discipline against your medical license

The final article for the “Seven Deadly Sins” series on avoiding discipline against your medical license will address pride. Pride seemed like such a proverbial “no-brainer” that I decided to save it for the last essay. Little did I know that I would get stuck on pride (a note-to-self moment?). So I conferred with my most trusted source of inspiration, who referred me to the well-known adage of Proverbs 16:18 which reads, “Pride goeth before destruction, and a haughty spirit before a fall.” Then I went to my second most trusted source of inspiration, Google, where I was delighted to learn how ecumenical the sin of pride is. That pride is recognized and derided by most religions suggests that pride must be a flaw with which most everyone struggles, but I have a question for you: do certain professions exemplify this sin better than others?

What happens when highly accomplished personalities find themselves in need of help? Does that translate to a self-perception of failure? Being so unaccustomed to failing, is it thus exponentially more difficult for a physician to ask for help? This is when pride does, in fact, precede destruction.

I know this is not glamorous, scandalous, or particularly memorable, but the first thing my colleagues and I thought of as examples of pride had to do with consultations — or more precisely, the failure to obtain a consultation. I guess if you look at it from pride’s point of view, a consultation literally requires asking for help. And wait! If you have to ask for help, you might have to admit you don’t know it all. Admitting you don’t know it all requires ... swallowing ... your ... pride.

I can think of one physician whose pride actually rendered him dangerous. In this particularly egregious case, the physician was not a trained surgeon; however, he took a one-week class in performing liposuction. The training recommended 20 proctored sessions prior to independently performing the procedures, but this physician was so arrogant he felt he did not need this level of oversight. Because the physician was performing the surgery in an outpatient setting, he was able to forego the proctoring requirements. The result: complication after complication. And, to compound this scenario, the physician was too proud to seek help when the complications occurred. One patient suffered from profuse post-operative bleeding. Rather than call an ambulance, or drive the patient to an emergency room, this physician actually tried to check her into a hotel! The hotel refused to accept her so the physician drove her to his home

where she bled to death. In cases where we can establish a physician poses an imminent threat to public safety, we are able to seek an interim suspension order (ISO). The ISO prohibits the physician from practicing medicine pending the outcome of legal proceedings seeking to revoke his or her medical license. This physician’s license was revoked (after it was suspended), and this case contributed to substantial legislative changes that now place requirements on outpatient surgery. It is unfortunate that laws have to be created to counteract such egregious levels of pride.

The standard of medical care is frequently breached when a physician fails to seek a consultation, which is naive on several levels. Consults provide access to quality care for the patient. Consults prevent errors. Averted errors prevent lawsuits. If a lawsuit or complaint is filed, then consults often prevent them from turning into formal action. (Of course, the consult is only really valuable when it is documented [see “Sloth,” *Medical Board Newsletter*, October 2006.])

The specialty we investigators observe as most susceptible to the consultation omission is pain management. Many physicians dabble in pain management. Many internists, psychiatrists, family physicians and even pediatricians will acquire a patient with an intractable pain condition, and they will get into trouble when they either didn’t refer the patient to someone who is well-versed with this specialty, or confer with a pain management physician only when the situation gets too complex. Remember, physicians who practice any specialty are held to the standard of care for that specialty they are practicing, whether they were formally trained or are board certified in that specialty.

Another common challenge for pain management practices is the drug-seeking patient who is quite cunning when it comes to compromising a physician’s lack of knowledge. What if the doctor faces the dilemma of the drug-addicted patient who is also suffering from chronic pain? All it takes is a consultation with experts and documentation of such.

Psychiatrists are sometimes conned into prescribing narcotics for pain management. Internists often prescribe psychotropic medications without the appropriate knowledge of their effects. And is it me, or has pharmacology itself become a Pandora’s Box of liability?

# Legislative Updates *(Continued from cover)*

## **AB 1224 (Hernandez, Chapter 507)**

### **Telemedicine: Optometrists**

Adds optometrists to the list of health care professionals who are allowed to practice via telemedicine. Defines collaborating optometrist for purposes of his or her participation in treating primary open angle glaucoma.

## **AB 1226 (Hayashi, Chapter 693)**

### **Medi-Cal: Provider Enrollment**

Provides, as of July 1, 2008, that a physician practicing in an individual physician practice, and enrolled and in good standing in the Medi-Cal program, and who is changing locations of that practice within the same county, is eligible to continue enrollment at the new location by filing a change of location form in lieu of submitting a completed application package. Also requires the State Department of Health Services to provide notice to the physician of receipt of the application package or the change of location form.

## **AB 1302 (Horton, Chapter 700)**

### **Health Insurance Portability and Accountability Act**

Extends the Health Insurance Portability and Accountability Implementation Act of 2001 (HIPAA) to July 1, 2010, when it will become inoperative, unless extended by statute.

## **AB 1531 (DeSaulnie, Chapter 413)**

### **Vehicles: Disabled Parking**

Limits the maximum consecutive number of times a person can renew a temporary disability placard to six. State or local agency off-street parking and parking facilities are required to state after July 1, 2008, on new or replaced signs designating a parking space as reserved for a disabled person, the minimum amount a person could be fined for parking in the space, without displaying the appropriate plates or placard.

## **AB 1687 (Brownley, Chapter 552)**

### **Confidential Information**

Provides that for purposes of allowing medical information to be disclosed to providers of health care, and for the purpose of diagnosis and treatment of a mental health condition of a minor, a provider may disclose medical information to any person who is legally authorized to have custody or care of a minor. This is for coordinating health care services and medical treatment provided to the minor. Prohibits those who are legally authorized to have custody or care of a minor who receive medical information from further disclosing that information unless the disclosure is for the purpose of coordinating health care services and medical treatment of the minor

and the disclosure is authorized by law. Provides that if a provider determines that the disclosure of medical information concerning a minor is reasonably necessary for the purpose of assisting in coordinating the treatment and care of the minor, that medical information may be disclosed to any other person who is legally authorized to have custody or care of the minor.

## **SB 472 (Corbett, Chapter 470)**

### **Prescription Drug Labeling Requirements**

Requires the state Board of Pharmacy to promulgate regulations that require a standardized, patient-centered, prescription drug label on all prescription medication dispensed to patients in California. The board is required to hold special statewide public meetings to seek information on the label requirements. Requires the Board of Pharmacy to report to the Legislature on or before January 1, 2010 on its progress and to report to the Legislature on or before January 1, 2013 on the status of implementation of the requirements.

## **SB 620 (Correa, Chapter 210)**

### **Dental: General Anesthesia**

Removes the January 1, 2008 sunset date on the permitting process for physicians who administer general anesthesia for dental patients.

## **SB 767 (Ridley-Thomas, Chapter 477)**

### **Drug Overdose Treatment: Liability**

Authorizes, until January 1, 2011, a licensed health care provider, who is permitted to prescribe an opioid antagonist, when acting with reasonable care to prescribe, dispense or distribute an opioid antagonist in conjunction with an opioid overdose prescription and treatment program without being subject to civil liability or criminal prosecution. Requires that local health jurisdictions operating opioid overdose prevention and treatment training programs collect specified data and report it to the Legislature.

## **SB 850 (Maldonado, Chapter 661)**

### **Vital Statistics: Certificate of Still Birth**

Enacts the Missing Angels Act, which requires the local registrar of births and deaths of the county in which a fetal death, where the fetus has advanced to or beyond the 20th week of uterogestation, to issue upon request, to the father or mother, a Certificate of Still Birth. This would be done on a form prescribed by the State Registrar of Vital Statistics. Defines stillbirth for

Experience gained from the last Board reorganization in 1994 is the basis of the following assumptions when the division system is changed to one Board with standing committees and the membership reduced:

- The work of the Board will remain the same regardless of the number of members or whether it retains or consolidates the divisions;
- The work of reviewing and adopting disciplinary or licensing decisions will not significantly increase or decrease for individual members, regardless of the organizational change, but will be more evenly distributed;
- Removing the legislative mandate of divisions will not prohibit members from working and developing expertise in licensing or disciplinary matters, nor would it prohibit the establishment of committees to perform most of the duties performed by the present divisions;
- Removing the mandated division structure will alleviate, in times of reduced membership, delays in the decision-making process due to meeting problems or lack of quorums;
- The change will expand the members' knowledge base on issues previously only heard in the division meetings.

The role of the Board's committees will increase their profile to all members of the Board. Previously, committees within the divisions were effectively not accessible to members and the other divisions. The committee chairs and the committee members are appointed by the president of the Board. The committees for this year are: Executive Committee, Access to Care Committee, Public Education Committee, International Medical Education Committee, Medical Errors Committee, Special Programs Committee, Cultural & Linguistic Competence Committee, Midwifery Committee, Diversion Committee, Special Faculty Permit Committee, Wellness Committee, Application Review Committee, and the Physician Recognition Committee.

One of my ambitions as Board president is that the current and future committee chairs will be dedicated/invested and empowered in the work of this Board and that the committee chairs will share their valuable and specialized knowledge with the full Board. During my continued term, I hope to empower Board members and provide them more investment opportunities in the work of the Board and a greater opportunity to share their knowledge. For those reasons and more, I believe this will be a better functioning organizational structure for the future of this Board.

I know many people who are prescribed so many pills, for so many varying ailments, that it's a wonder most physicians know all of what the patient is receiving, let alone how these various medications interact.

Here's another area where we often see problems because of pride. There are a lot of doctors out there who are brilliant practitioners, but they have no business acumen. Being too proud to admit it, they are lured into contracts and obligations due to their business naiveté and end up being cited for all kinds of violations (failing to have a fictitious name permit, aiding/abetting the unlicensed practice of corporate medicine, advertising violations). I hate to be the bearer of bad news, but ignorance is never a valid defense.

And finally, how about the most common demonstration of pride? How about being afraid to ask for emotional help? With the stresses of a busy practice, society's extraordinary expectations, extracting compensation from insurance companies or HMOs, malpractice premiums, complaints, technology, traffic, not to mention the activities of just a normal day, how do most physicians handle that cornucopia of stress? In my line of work, we see the

physicians who find it easier to succumb to a panacea of alcohol or drugs than to ask for help. (See *"Physician Wellness as Constrained by Burnout," Medical Board Newsletter, November 2007.*)

Pride challenges us all to some degree. A healthy sense of self-pride isn't entirely horrifying, and I know in my experience, whenever I exceed a healthy sense of esteem, an omniscient pride-ometer is just waiting to slap me down to reality.

I am proud to have had the opportunity to write these words of caution to you. I hope there is a parcel of information contained within this catalog of sins to help you navigate the investigative process and have a better understanding of what we investigators encounter in our job. Most important, I hope there was some advice within these sins that helps keep someone out of this newsletter! But if I have failed, and if you do end up here, we can consume our pride together and learn from the experience. After all, as C.S. Lewis said, "A proud man is always looking down on things and people; and, of course, as long as you're looking down, you can't see something that's above you."

## Medical Board's Physician Humanitarian Award accepted posthumously

One of the Medical Board's two recipients of its Physician Humanitarian Award for 2007, Ron Bangasser, M.D. of Redlands, passed away on May 2, 2007 of colorectal cancer.

His death certainly was a loss not only for his family and friends, but also for the patient population of Redlands.

At its November 2 meeting in San Diego, the board was honored to have his widow, Dr. Susan Bangasser, accept the award on his behalf. She was accompanied by their daughter, Dr. Debra Bangasser.

Dr. Ron Bangasser, a family practitioner, was the director of the Wound Care Center at Redlands Community Hospital. He introduced hyperbaric chambers to the wound-care ward at that hospital in 1982, and that unit now treats more than 4,000 patients a year. He was a member of numerous organized-medicine associations and societies, and participated in causes ranging from domestic violence awareness to the United Way. He was an outspoken advocate of access to medical care for all, regardless of income, and participated in medical organizations where his voice could be heard.

He promoted the involvement of medical students and residents in organized medicine, sponsoring at least two students from Loma Linda University School of Medicine to attend CMA's Legislative Leadership Day. For two decades, he served as team physician for San Bernardino Valley College and the San Bernardino Stampede Professional Baseball team. He was highly respected by his peers, his friends, his patients, elected officials, and his community.

## Free online domestic violence CME helps California physicians to better recognize intimate partner (domestic) violence (IPV)

*Web site and CME paid for by a grant from Blue Shield of California Foundation; Project endorsed by CMA, Family Violence Prevention Fund and Kaiser Permanente*

A free online CME course, Respond to Domestic Violence, offers California physicians the opportunity to earn up to 16 AMA PRA Category I credits or 16 AAFP Prescribed credits. The program is available at [www.RespondtoDV.org](http://www.RespondtoDV.org).

IPV is more common than most physicians may believe and studies have shown that experienced physicians have trouble recognizing and responding to IPV in their practices. California physicians may not be aware that they and other health care practitioners are required to report to local law enforcement authorities the names of persons whom they treat for injuries that are the result of assault or abuse, including abuse by a spouse or cohabitant (California Penal Code §11160).

In 2006, Blue Shield of California Foundation decided to help California physicians to better recognize IPV. The foundation teamed up with a group of national experts, led by Zita Surprenant, M.D., of Kansas University, and an Arizona company specializing in online CME, to provide a customized IPV CME program for California physicians.

The program uses an interactive case-based teaching approach. It emphasizes the practical management of IPV and explains California's reporting requirements. The program has been shown in two published studies to improve physician confidence in managing IPV.

Since its launch in July 2006, more than 1,700 California physicians have enrolled in the online program, earning 6,000 CME credits. Physicians who complete the program have been enthusiastic, with 90 percent of them rating the program "above average" or "excellent." Almost three quarters of physicians expect to change their practice based on what they learned from the program.

According to Dr. John Harris, president of Medical Directions, the company that developed the program and hosts the [www.RespondtoDV.org](http://www.RespondtoDV.org) Web site, the online program will provide free CME to licensed California physicians at least until July 2008. "We believe this is a worthy project," Dr. Harris said. "We plan to promote the IPV program this winter and are seeking support to keep it available beyond July."

# The goals of the Medical Board's Wellness Committee

The American Board of Holistic Medicine defines optimal health as “the conscious pursuit of the highest level of functioning and balance of the physical, environmental, mental, emotional, social, and spiritual aspects of human experience, resulting in a dynamic state of being fully alive.” Given the demands and stress of a busy medical practice, physicians are unlikely to consciously pursue anything more than a good night's sleep. Can you imagine if all physicians are allowed or allow themselves time to balance the physical, environmental, mental, emotional, social, and spiritual aspects of their lives? Many organizations in California have realized the rewards of physician well-being and the Medical Board of California would like to contribute to this worthy pursuit.

I have seen those that give up the fight to achieve balance and leave medicine completely. Take Dr. Smith (name changed to protect the departed). She started medicine with a love for science and learning, excelled in medical school and shined with her abundance of compassion. She completed her residency at the same time she married and soon after started a family. As her practice opened, the word about her compassion and knowledge spread. Her patient volume overwhelmed her available appointments, but Dr. Smith made room for the extra patients. As her practice thrived, she had a child and was due to take her board exams. Her patients, her family, and her field continued the same expectations on Dr. Smith but the cumulative demands were overwhelming. She felt like she was cheating each patient from appropriate face-to-face time, she felt guilty leaving her newborn, she could not dedicate the time to study for her board exams, and she was named in her first medical malpractice lawsuit. This was all too much for a physician who loved learning and prided herself on compassionate, competent care. Dr. Smith left medicine to dedicate herself to her family and find another area that would allow her time to enjoy her love of learning. Dr. Smith's departure is not only a personal loss but a loss to her patients and the medical community.

Imagine if Dr. Smith “consciously pursued the highest level of functioning and balance?” Imagine if she realized she needed to feed her passion to learn and give more time to her family. Consider a society that recognized the need to have different job descriptions. As compassionate caretakers, doctors like Dr. Smith have difficulty setting limits and saying “no.” This was one of the hardest lessons I had to learn. No, I cannot take any more new patients. No, I cannot have a 100 percent clinical practice and feel well-rounded. No, I cannot pursue another term on the Medical Board at this time in my children's lives. No, I cannot come in early

because that is the time for my four-mile run. I've been proud of my fellow board members and medical colleagues that have had the insight to make small decisions and career-altering decisions to enhance their well-being.

How can we as a medical board prevent the departures of caring and competent doctors like Dr. Smith? The board believes that any step it can promote in the prevention of physician “unwellness” is a worthwhile one. Although most board members and staff have realized this concept, it had not been addressed in a formal setting until now. The 2007 Medical Board created a Wellness Committee to investigate and promote issues of physician well-being. With the goal of furthering the board's consumer protection mission by encouraging and guiding licensees to promote their personal and professional well-being, the committee met for the first time on September 26, 2007.

The committee discussed the function of well-being committees at each hospital. Although some of these committees have been able to be proactive and preventative, many end up in a responsive mode, dealing with behavior and substance abuse issues. A negative connotation often follows this responsive nature. The Medical Board's committee hopes to be proactive and focus on the issue of balance. With the above in mind and a realization of limited resources, our immediate goals are the following:

- To increase physician awareness of the importance of physician well-being through a series of articles published in the *Medical Board of California Newsletter*.
- To collate resources in California that promote physician wellness.
- To encourage and possibly reward physicians for taking time to become knowledgeable regarding the issues of physician well-being.
- To perform outreach activities that promote physician wellness.

Even if we only affect the life of one Dr. Smith, “I feel our work will have been worthwhile.”

# Senator Sam Aanestad, D.D.S.

He served three terms on the California Dental Association Council on Legislation, including three years as chairman, and he served two terms as president of the Butte-Sierra District Dental Society. He is also a member of the California and American Dental Associations.

Senator Aanestad received both his bachelor of arts and doctor of dental surgery degrees from the University of

California at Los Angeles. He then completed a four-year oral and maxillofacial surgery residency at Highland General Hospital in Oakland. Dr. Aanestad received a master in public administration degree from Golden Gate University in 1991. He was honored by the UCLA School of Dentistry as its "Alumnus of the Year" in November 1998.

In the current legislative session, Senator Aanestad has authored six bills that directly impact the Medical Board of California (SBX1 7, SBX1 8, SB 238, SB 253, SB 438, and SB 822). Most notably, Senate Bill X1 7 (2007) helps health care providers who service qualified low-income persons. If passed, SBX1 7 would increase Medi-Cal reimbursement rates for health care providers to 80 percent of the reimbursement rate of the federal Medicare Program with annual increases tied to the California Consumer Price Index. Senate Bill X1 8 would allow a physician a tax credit in an amount equal to 50 percent of the fair market value of uncompensated medical care provided to an uninsured individual.

In the California State Senate, Dr. Aanestad's top priorities are new job and business creation in Northern California, preserving rural health care, protecting north state water, and serving the needs of the citizens of the 4th Senate District, which includes Butte, Colusa, Del Norte, Glenn, Nevada, Placer, Shasta, Siskiyou, Sutter, Tehama, Trinity, and Yuba counties.

this purpose to be delivery of a fetus where there was a naturally occurring intrauterine fetal death that occurred after a gestational age of not fewer than 20 weeks.

### **SB 1047 (Committee on Business and Professions, Chapter 354) Professions and Vocations**

Requires each of the boards under the Department of Consumer Affairs to meet at least three times each calendar year and at least once each calendar year in Northern California and in Southern California. Authorizes the director of Consumer Affairs to exempt any board from the meeting requirement upon a showing of good cause and to call a special meeting of the board when a board is not fulfilling its duties.

### **SB 1048 (Senate Business and Professions Committee, Chapter 588) Healing Arts: Omnibus**

This bill has several provisions. Some impact statutes governing the Medical Practice Act. The first provision, amending B&P Code section 2177, allows an applicant who obtains a passing score on Part III of the USMLE in more than four attempts and who meets the requirements of section 2135.5 to be eligible for a physician's license. The second provision, amending B&P Code section 2313, makes current the language to reflect that references to B&P Code section 801 now refer to section 801.01. It also revises language on collecting information on complaint forms as it is no longer practical to report on forms sent by mail, as many are printed from the Web site.

## Explanation of disciplinary language and actions

**"Effective date of decision"** — Example: "Sept. 12, 2007" at the bottom of the summary means the date the disciplinary decision goes into operation.

**"Gross negligence"** — An extreme deviation from the standard of practice.

**"Incompetence"** — Lack of knowledge or skills in discharging professional obligations.

**"Judicial review pending"** — The disciplinary decision is being challenged through the court system, i.e., Superior Court, Court of Appeal, or State Supreme Court. The discipline is currently in effect.

**"Probationary License"** — A conditional license issued to an

applicant on probationary terms and conditions. This is done when good cause exists for denial of the license application.

**"Public Letter of Reprimand"** — A lesser form of discipline that can be negotiated for minor violations, usually before the filing of formal charges (Accusations). The licensee is disciplined in the form of a public letter.

**"Revoked"** — The license is canceled, voided, annulled, rescinded. The right to practice is ended.

**"Revoked, stayed, five years probation on terms and conditions, including 60 days suspension"** — "Stayed" means the revocation is postponed. Professional practice may continue so long as the licensee complies

with specified probationary terms and conditions, which, in this example, includes 60 days of actual suspension from practice. Violation of probation may result in the revocation that was postponed.

**"Stipulated Decision"** — A form of plea bargaining. The case is formally negotiated and settled prior to trial.

**"Surrender"** — To resolve a disciplinary action, the licensee has given up his or her license — subject to acceptance by the board.

**"Suspension from practice"** — The licensee is prohibited from practicing for a specific period of time.
