## New RP-VITA robots now in hospitals

Imagine needing an emergency stroke consultation in the hospital, when time is of the essence, and a qualified specialist is not available. Receiving help is now as simple as booting up an iPad app that sends a robotic presence to your bedside, ready to remotely beam in a licensed professional who is suited to help with your needs.

In the Mercy Telehealth Network, the state-of-the-art RP-VITA robot patrols the intensive care units of Mercy General, Mercy San Juan and Mercy Folsom, ready to provide emergency consultations at a moment's notice.

"We use these robots because we're a highly specialized unit," said Alan Shatzel, DO, Medical Director, Neurology, of the Mercy Telehealth Network. "If the person we need right now is a 25 minute drive away, we can get them here right now. [Those 25 minutes], it's life and death. If you don't make the right decision, right now, that can change the outcome for that particular scenario."

Developed by InTouch Health, in conjunction with iRobot (creators of the Roomba vacuum), the RP-VITA has a variety of features that assist a physician in consulting with a patient. The robot is 5'6" with a flat-screen monitor "head" so the patient can speak to the doctor, face-to-face. The robot is also equipped with a zoom-lens camera, microphone, speakers, and a handset for

private conversations. There is even an attachment for a stethoscope.

"We want everything to be as seamless as possible," said Jason Close, manager, Mercy Telehealth Network.

The RP-VITA can be controlled remotely via an iPad interface or a Windows computer desktop application. The floor is digitally mapped into the robot's memory so that it knows where to go when needed. However, it also has sensors that allow it to re-route if something or someone gets in its way.

The robot can "see" people and objects and avoid bumping into them. During a recent demonstration, the RP-VITA was asked to go to one of the hospital rooms

# President's Message

On February 21-22, 2013, the Medical Board of California (Medical Board), together with the Board of Pharmacy, hosted a Forum in San Francisco to examine the alarming epidemic of prescription drug abuse – nationally and in California – and to identify the elements of an action plan to address the abuse and misuse of prescription drugs. This issue is critically important for the Medical Board in carrying out its primary mission of consumer protection. Over the course of two days, representatives from multiple organizations, including the Drug Enforcement Administration, White House Office of National Drug Control Policy, Office of the Attorney General, and licensees and representatives from both the Medical and Pharmacy Boards, discussed the root causes of this problem. The speakers identified actions that policy makers, prescribers, dispensers and members of the public can take to address the multidimensional problem.

The Forum included presentations on the role of federal and state

governments in public policy related to prescription drug abuse, prescription drug trafficking/diversion, prosecutors' perspectives about abuse and diversion of narcotics and the hidden motivation for fraud. Several speakers emphasized that collaboration between pharmacists and physicians is essential, as we each carry out our separate but related responsibilities to prevent prescription drug abuse. Materials from the Forum are currently available on the Medical Board's Web site ([www.mbc.ca.gov/pain\\_forum\\_february\\_2013.html](http://www.mbc.ca.gov/pain_forum_february_2013.html)) including links to video recordings of the various speakers, their corresponding PowerPoint presentations, and handout materials. The Forum was very well-received by attendees and a large majority indicated that the presentations were effective and enhanced their knowledge base.

In follow up, the Medical Board will be convening a Prescribing Task Force to identify successful approaches to prescribing controlled substances, to revisit the pain management guidelines, and to address, in collaboration with the Board of Pharmacy, appropriate communication and information sharing between prescribers and dispensing pharmacists regarding prescriptions for controlled substances.

The task force will be co-chaired by Medical Board Members Barbara Yaroslavsky and Michael Bishop, M.D., and will involve prescribers – physicians, nurse practitioners, dentists, etc.; pharmacists; prescribing and dispensing associations; law enforcement agencies, such as the Drug Enforcement Administration, the District Attorney's office, Sheriff's

office, etc.; State agencies such as California Department of Public Health, Department of Health Care Services and Department of Insurance; consumer and advocate groups; other healing arts boards (pharmacy, dental, registered nursing, etc.); insurance companies; and Senate and Assembly Committees. The meetings of the Task Force will be open to the public, and the meeting times and locations will be posted on the Medical Board Web site: <http://www.mbc.ca.gov/board/meetings/Index.html>

One of the important sources of misuse and abuse of prescription drugs, particularly among adolescents and teens, is unused medications in home medicine cabinets. On April 27, the Drug Enforcement Administration, working with local law enforcement agencies, held another National Prescription Drug Take-Back Day. In total, 742,497 pounds of unused prescription medication was collected from more than 5,829 locations. Officials also provided information to the public about the potential for abuse of medications. The Medical Board will continue to post dates of future Take-Back Day events on the Web site and in the Newsletter.

In this issue you will find a story about the SCOPE of Pain CME program available through Boston University (see page 10). This course provides education on the safe and effective use of opioids in the management of chronic pain. The Medical Board strongly encourages physicians to take advantage of available CME programs on the evolving field of medication management for patients with chronic

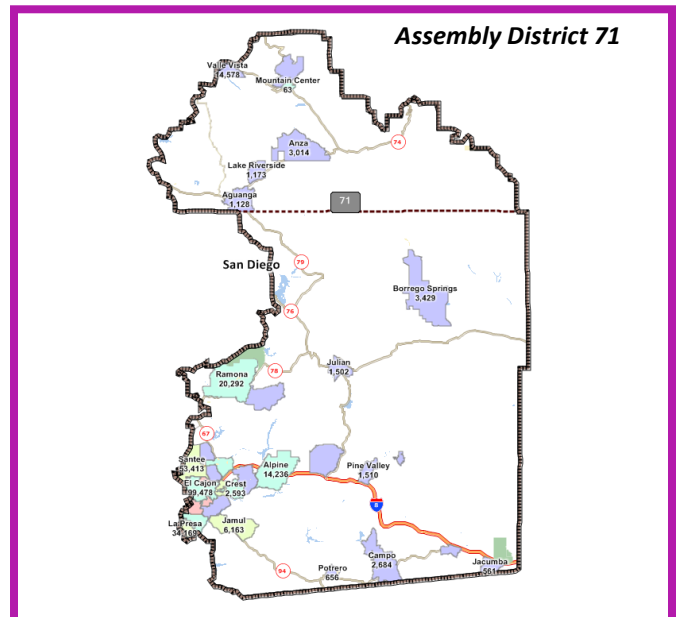

# You Asked For It

## Questions received from the Web

**Q. I have a small laboratory as part of my medical office. Am I required to register as a clinical laboratory?**

Yes. A physician office laboratory (POL) is considered a clinical laboratory if any patient testing is done, such as urine dipstick tests, fingerstick blood tests, or Pap smear review and reporting. Your POL must either be licensed or registered. For more information, please call the Department of Public Health-Laboratory Field Services at (510) 620-3796.

**Q. How many Physician Assistants and/or Nurse Practitioners is a physician allowed to supervise?**

Current law allows a physician to supervise no more than four physician assistants or four nurse practitioners at any moment in time. A physician may supervise a combination of nurse practitioners and physician assistants as long as the stated limits are not exceeded.

**Q. I am having a difficult time finding opportunities to earn CME hours. Can you provide me with some suggestions?**

There are many educational activities, which can qualify for CME credit. You can contact any of the following accrediting organizations for specific information about qualifying programs and activities: California Medical Association--Institute for Medical Quality (CMA/IMQ) (415) 882-5151; the American Medical Association (AMA) (800) 621-8335; the Accreditation Council for Continuing Medical Education (ACCME) (312) 527-9200; or the American Academy of Family Physicians (AAFP) (800) 906-6000.

**Q. I believe a patient stole a prescription pad from my office. Am I required to report this and to whom?**

If your tamper-resistant prescription forms are lost or stolen, you must first report the theft to your local law enforcement agency to obtain the report number that must be included in your report to the State Department of Justice, Bureau of Narcotic Enforcement, CURES Program. You must also report the theft to the Drug Enforcement Administration's regional office in your area, and a written narrative should be provided to the Medical Board's Central Complaint Unit.

**Q. I just began practicing and was told I need to display a sign in my office regarding my education.**

There are actually two signs you are mandated by law to display in a prominent area in your medical office: (1) a Notice to Consumers which states that medical doctors are licensed and regulated by the Medical Board of California, and (2) a sign stating your name, highest level of academic degree, and your board certification, if any. These signs may be placed individually or as one sign. but an employee walked in front of it with a handcart. The robot stopped, rotated, and continued on to the room while maneuvering around the cart.

When called, the RP-VITA can either travel automatically or it can be controlled manually by the user. When it arrives at its destination, it waits for someone to open the door for it. When the RP-VITA is no longer needed, it makes its way back to the docking station on its own and plugs itself back in to recharge.

The robot is used primarily for neurology, nephrology and neonatology purposes and increasingly for mental health. Shatzel said that in cases of stroke response, every minute lost is critical and that, in some areas, there are not enough neurology specialists to be everywhere at once.

However, with the RP-VITA and various other telemedicine robot devices, patients do not have to lose precious time, waiting for a specialist to travel to them.

“Patients have strokes at all times of the day. It’s not fair if you’re the person who comes in at 9 p.m. and you don’t have that specialty expertise,” Shatzel said. “But if you come in at 3 p.m. you do. Telemedicine is being used to even it out and get someone to the bedside right now who can make those decisions and take care of you.”

The RP-VITA is being used at three Mercy locations, but there are other models and devices that are used throughout California right now as well, Close said.

The RP-7, which is the current model’s predecessor, is controlled via joystick and doesn’t have some of the same

bells and whistles. The RP-Lite does not have the platform that helps drive the device and is cart-based, allowing someone to push the robot where it is needed. There is also a hand-held device, the RP-Xpress, which Close describes as a workhorse robot because it’s inexpensive, portable and is useful in many different applications, such as meeting attendance and pre-hospital screenings.

Shatzel lauded the strengths of the telemedicine robots, improving access to care that otherwise would not be readily available. However, one of the limitations is that you cannot physically touch somebody.

“There are conditions in neurology and other fields where you have to be able to physically touch somebody,” Shatzel said. However, he said that there is a nurse at the bedside with the RP-VITA at all times and that they can assist with certain aspects of a consultation or with tests.

Shatzel said that patients are initially surprised to see the robot and there is a “wow” factor when dealing with a doctor through the RP-VITA, but that it quickly turns to appreciation when they recognize the level of expert care they are receiving.

He said that people do not realize there still is not that level of consistency throughout every hospital and that some smaller or remote facilities just do not have access to the specialists they need.

“If you go to that 20-bed hospital, there’s a high probability that they won’t be able to take care of most things that are wrong with you,” Shatzel said. “Telemedicine, I think, is changing all of that though, in a good way.”

pain. The science and art of navigating the dual challenge of appropriate and adequate pain management while simultaneously avoiding the risks and harms of creating opioid dependence and addiction are rapidly changing, and the Medical Board will be using all its communication and education resources to keep physicians and members of the public informed, including posting notices of CME programs on the Web site. Pending legislation, Senate Bill 809 (DeSaulnier), will fund modernization of the CURES system to improve licensee access and use of the system to obtain real-time

information about patients’ prescription history in order to identify doctor or pharmacy shopping, as well as enable the Medical Board to identify potentially problematic prescribing patterns. The Medical Board believes this bill is very important to enhance the system and optimize its utility and responsiveness.

The Medical Board is planning a similar prescribing forum in the future in Southern California, as well as identifying other venues and vehicles to educate, inform and engage physicians, other prescribers and members of the public in a meaningful effort to turn the tide on the devastating epidemic of prescription drug abuse and misuse.

# Living Donation California launched to inspire and inform potential living kidney donors

Donate Life California

On May 14, Living Donation California was launched as a first-of-its-kind, state-authorized information and referral service to inspire and inform people to be altruistic living kidney donors. Through its Web site, [www.LivingDonationCalifornia.org](http://www.LivingDonationCalifornia.org), the free service provides information about the risks and benefits of living donation, and facilitates the referral of potentially eligible individuals for a full evaluation by a transplant center – all with the hope of increasing the number of living donor transplants and lessening both the number of Californians on the organ transplant waiting list and the time that they wait for their lifesaving gift.

The news conference at the California State Capitol was an opportunity for members of the transplant community to come together and recognize living kidney donors for their lifesaving gifts. Many speakers had a personal connection to organ donation: transplant surgeon Dr. Jeffrey Veale of UCLA Ronald Reagan Medical Center; State Senator Tom Berryhill, 12-year heart transplant survivor; Kelly Wright, living kidney donor; JePahl White, kidney recipient, who along with his wife, participated in a lifesaving kidney chain; and Tad Suwa, Sacramento firefighter waiting for a kidney transplant.

Currently, more than 17,000 Californians are waiting for a kidney transplant. The waiting list for those in need is ten years – twice as long as the national average. With such a shortage of kidneys available for transplant, living kidney donation is increasing in popularity. The vast majority of living kidney donors are family members or close friends; however, a growing number of altruistic kidney donors are stepping forward to offer the gift of life.

On April 2, Kelly Wright, who was inspired while watching the 2012 Donate Life Rose Parade Float, donated a kidney to a Boston man she met on Facebook in January. She said she has no regrets.



“I will never have a bigger accomplishment in my life than having one of my kidneys working inside of another human who may have died without it. Living donation is a blessing for both donor and recipient,” Wright said.

While altruistic donors may be matched to single recipients, they also play a key role in “kidney chains” which link a series of incompatible pairs of donors and recipients who are compatible with each other. (For example, an altruistic donor gives a kidney to Wife 1, then Husband 1 donates to Wife 2, and Husband 2 donates to Wife 3, and so on). Altruistic donors are key to starting kidney chains because they are not linked to a specific recipient.

Living Donation California was inspired by Apple founder Steve Jobs, who in 2009, during his battle with pancreatic cancer, received a liver transplant. However, during that process he grew frustrated over the shortage of organs in the United States. In cooperation with then-Governor Arnold Schwarzenegger and Donate Life California, The Altruistic Living Donor Registry Act of 2010 (SB 1395) was signed into law, authorizing the state’s organ procurement organizations (OPOs) to establish a service designed to “promote and assist live kidney donations.” Living Donation California is that service.



# Physicians encouraged to discuss patients' end-of-life wishes

Physicians, families and other health care providers continually struggle to interpret the intent of patients who have failed to complete an advance directive. Physicians are encouraged to talk with their patients about important documents that will make their medical treatment wishes clear, if they are incapacitated or face a terminal illness.

In California, a document called an Advance Health Care Directive is the legally recognized format for a living will. A traditional living will only states a patient's desire not to receive life-sustaining treatment if he or she is terminally ill, or permanently unconscious. But an Advance Health Care Directive allows patients to state their wishes about refusing or accepting life-sustaining treatment, in any situation.

Without a directive, many families find themselves in the agonizing position of having to make a decision on how their loved one wishes to be cared for, particularly if there have been no prior discussions on the topic.

The Advance Health Care Directive also has replaced the Durable Power of Attorney for Health Care (DPAHC) as the legally recognized document for appointing a "health care agent" in California. A health care agent has legal authority to make decisions about a patient's medical care if the patient becomes unable to make these decisions.

When appropriate, physicians are encouraged to discuss Physician Orders for Life-Sustaining Treatment (POLST) with patients. POLST forms are

used for patients with a serious illness or whose life expectancy is a year or less and outlines a plan of care reflecting the patient's wishes concerning medical interventions at life's end. POLST complements an advance directive by turning a patient's treatment preferences into actionable medical orders.



CMA's Advance Health Care Directive and POLST kits, available in English and Spanish, include legal forms and wallet identification cards, and answer many of the most frequently asked questions about these issues.

CMA encourages physicians to keep a supply of forms in their office for patient use. Members can purchase Advance Health Care Directive and POLST kits for \$5 each at CMA's online bookstore (nonmember price is \$6). Members who order 10 or more receive a 30 percent discount and member orders of 500 or more receive an additional discount of 25 percent.

# The Payment Error Rate Measurement (PERM) Program

Department of Health Care Services

The California Department of Health Care Services (DHCS) wishes to notify all California Medi-Cal providers of the Payment Error Rate Measurement (PERM) review that is being conducted in California by the U.S. Department of Health and Human Services, Centers for Medicare and Medicaid Services (CMS).

The purpose of PERM is to identify erroneous payments made to Medicaid and the Children's Health Insurance Program (CHIP) in all 50 states and report the improper payment estimates to Congress.

CMS has contracted with the Review Contractor (RC) A+ Government Solutions, Inc. to perform the review. The RC will collect the medical records from the providers via secure fax and mail for the sampled claims and will perform the medical and data processing reviews to determine if the claims were paid correctly.

Approximately 167 Medi-Cal claims will be selected per quarter, between October 1, 2012 and September 30, 2013. Providers whose medical records have been selected for review will begin receiving requests from the RC for copies of the medical records beginning in June 2013 and ending in July 2014.

Providers will also be required to send a duplicate copy of the medical records requested by the RC to

DHCS. DHCS is taking this proactive step in order to review the submitted documentation and determine if further information is needed to support the claim. In cases where DHCS determines that the medical records have not been submitted or further information is needed, providers will be contacted by a DHCS representative, either by phone or in person, to help facilitate obtaining copies of this important documentation.

DHCS is urging all providers to comply with requests for medical records from the RC and DHCS. Failure to comply with the request from the RC will result in an error being counted against California, and DHCS will be required to recover the claim payment amount from providers. Your cooperation will help ensure that the payment measurement rate is accurate and that California retains its much needed federal match monies for the Medi-Cal Program.

# Available pain management education

## SCOPE of Pain: Safe and Competent Opioid Prescribing Education

Prescription drug abuse is an ongoing problem throughout the nation. It is important that physicians familiarize themselves with safe practices when it comes to opioid prescribing. A new course from Boston University, offered in collaboration with the Council of Medical Specialty Societies (CMSS) and the Federation of State Medical Boards (FSMB), aims to help educate prescribers in the safe use of these medications.

Launched on March 1, 2013 with the first phase – an online educational activity – the program addresses many key elements of the physician education component of the Obama Administration's prescription drug abuse prevention plan on prescriber education released in April 2011.



This program, titled SCOPE of Pain, is a series of continuing medical education activities addressing the safe and competent use of opioids for managing chronic pain. The program consists of:

- A free 3-module web-based activity;
- 10 live conferences held around the U.S. that will include Policy and Resource panels; and
- Train-the-trainer workshops.

### **Extended Release/Long Acting Opioids: Achieving Safe Use While Improving Patient Care**

In response to the growing problem of the abuse, misuse and diversion of extended-release and long-acting (ER/LA) opioid drugs, the FDA approved a risk evaluation and mitigation strategy (REMS) for ER/LA opioid medications. This initiative will provide a unique opportunity to reach and provide effective prescriber-focused education on the safe and effective prescribing of ER/LA opioids to safely manage pain.

FDA statistics indicate that more than 33 million Americans, teens and older, misused ER/LA opioids during 2007, up from 29 million in 2002. Yet these drugs have long been a major tool in the management of chronic pain or to help those who suffer from a painful injury or surgery. Highly effective yet highly addictive, the challenge posed by ER/LA opioids-patient assessment, prescribing guidelines, managing treatment and addressing alternatives when opioids fail are the critical issues addressed by this workshop.

## UV protection resources

The Environmental Protection Agency (EPA) Web site has a variety of resources available that can help you stay informed about the UV Index, which indicates the strength of solar UV radiation on a scale from 1 (low) to 11+ (extremely high).

Too much exposure to UV rays can change skin texture, cause the skin to age prematurely, and can lead to skin cancer. UV rays also have been linked to eye conditions such as cataracts. Skin cancer is the most common form of cancer in the United States. According to the Centers for Disease Control and Prevention (CDC), about 65 - 90% of melanomas are caused by exposure to ultraviolet (UV) light.

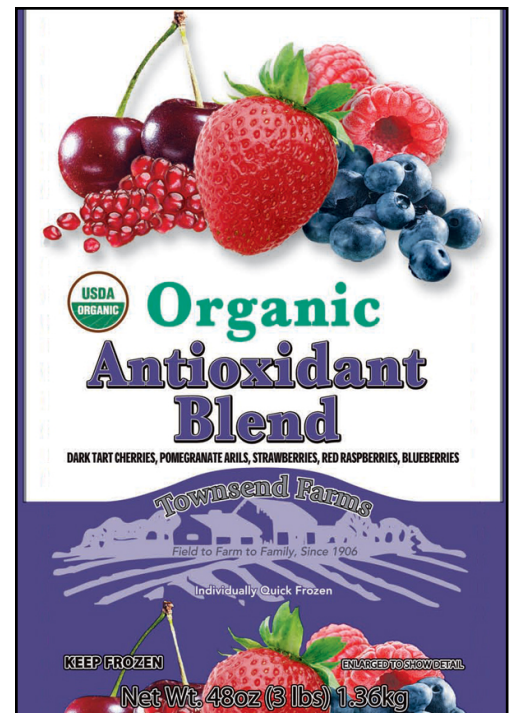

# Outpatient Surgery Settings Frequently Asked Questions

The Medical Board has developed a series of Frequently Asked Questions on the subject of Outpatient Surgery Settings. Here is a sample of the questions that are answered in this document.

***Q: What is an Outpatient Surgery Setting or an Outpatient Ambulatory Surgery Setting?***

A: It's any facility, clinic, center, office or other setting that is not part of a general acute care facility, where anesthesia, except local anesthesia or peripheral nerve blocks, or both, is used in compliance with the community standard of practice in doses that, when administered, have the probability of placing a patient at risk for the loss of the patient's life-preserving protective reflexes.

***Q: Who can own an Outpatient Surgery Setting?***

A: An Outpatient Surgery Setting can be owned by an association, corporation, firm, partnership, or individual person.

***Q: Does an Outpatient Surgery Setting need to be licensed or accredited?***

A: Anytime a medical procedure is performed under anesthesia that places patients at risk of losing their life-preserving protective reflexes, the medical procedure must be done in a licensed, certified, or accredited setting.

## Ending the physician/patient relationship

While a physician may end the physician/patient relationship, there are several steps one should take in order to avoid allegations of patient abandonment, which is considered unprofessional conduct. By following these guidelines, you are taking the appropriate steps to ensure that the patient can make a steady transition for continuous treatment.

A physician should notify patients of the following in writing when the physician wishes to discontinue care:

1. The last day the physician will be available to render medical care, assuring the patient has been provided at least 15 days of emergency treatment and prescriptions before discontinuing the physician's availability.
2. Alternative sources of medical care, i.e., refer patient to other physicians, by name, or to the local medical society's referral service.
3. The information necessary to obtain the medical records compiled during the patient's care (whom to contact, how and where).

Regarding the last step pertaining to medical records, there is a Frequently Asked Questions section on the Medical Board's Web site to help patients and physicians alike understand their rights/obligations when it comes to acquiring and providing copies of medical records. 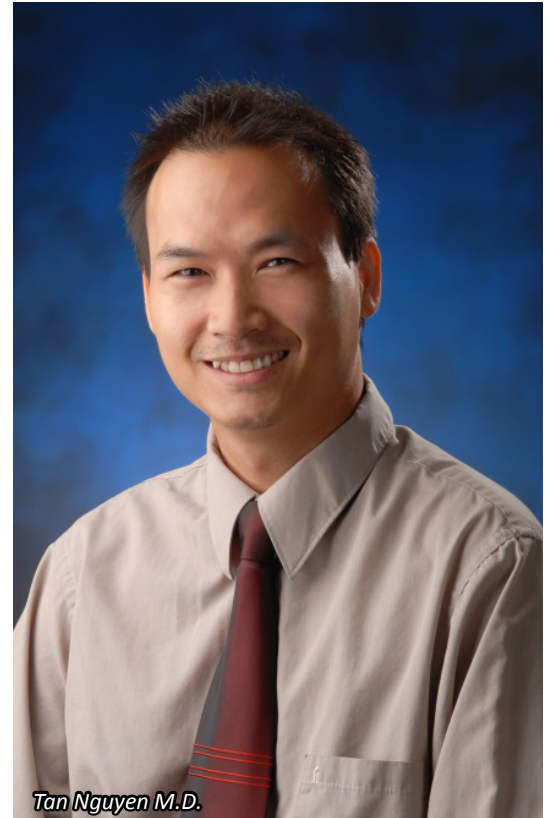

## Steven M. Thompson Loan Repayment Program Recipient

Tan Nguyen, M.D. is currently working at the Family Health Centers in Santa Ana and Anaheim. His experiences of living in Vietnam and training for primary care at Michigan State University-College of Human Medicine had made a major impact in his decision to work in a health care shortage area. For Dr. Nguyen, the privilege of taking care of the whole family is tremendously rewarding. It is not infrequent that his patients will say, "This is the very first time I get to see a doctor." His care for a population of largely underinsured Hispanic and Vietnamese patients allows him to continue planting a deeper root in his community.

Dr. Nguyen recently completed his fellowship training in Patient Centered Medical Home to help his clinic become ready for the coming changes to healthcare delivery. Currently, he is collaborating with various community organizations in providing education and improving access of care for Vietnamese children with asthma. He is also working with the Family Medicine Interest Group at UC Irvine to help encourage and provide support for students going into primary care. Dr. Nguyen has a long term goal of continuing to help those in need in the community and reach out to other underserved areas similar to where he grew up.

## FDA – Two inhalers containing CFCs off the market at year's end

*U.S. Food and Drug Administration*

The last two inhalers in the United States that contain ozone-damaging chlorofluorocarbons (CFCs) - Combivent Inhalation Aerosol and Maxair Autohaler - will both be taken off the market by the end of this year. People with asthma and chronic obstructive pulmonary disease (COPD) who use these inhalers will need to talk to their health care providers about a prescription for an alternative.

Most inhalers using CFCs have already been phased out. The most widely used—albuterol CFC inhalers—were phased out in 2008 and replaced with alternatives that use propellants called hydrofluoroalkanes (HFAs). The most recent phase-out was of over-the-counter epinephrine inhalers sold under the brand name Primatene Mist, which were phased out at the end of 2011.

While all FDA-approved inhalers currently on the market have been shown to be effective, there are some differences between the products. For example, products propelled by HFA may taste and feel different than the spray from CFC-propelled inhalers. Although some consumers note that the spray from an HFA inhaler feels less forceful, this does not mean that the medicine is not working. Other alternative medications may use no propellant at all.

## Explanation of disciplinary language and actions

### **"Effective date of decision"** —

Example: "March 14, 2012" at the bottom of the summary means the date the disciplinary decision goes into operation.

**"Gross negligence"** — An extreme deviation or departure from the standard of care.

**"Incompetence"** — Lack of knowledge or skills in discharging professional obligations.

**"Judicial review pending"** — The disciplinary decision is being challenged through the court system, i.e., Superior Court, Court of Appeal, or State Supreme Court. The discipline is currently in effect.

**"Probationary License"** — A conditional license issued to an applicant with probationary terms

and conditions. This is done when cause exists to deny the license application, but limitations can be put in place to protect the public.

**"Public Letter of Reprimand"** — A lesser form of discipline that can be negotiated after or in lieu of the filing of formal charges. The reprimand may include educational and clinical training requirements.

**"Revoked"** — The right to practice is ended due to disciplinary action. The license is invalidated, voided, annulled, or rescinded.

**"Revoked, stayed, five years probation on terms and conditions, including 60 days suspension"** — "Stayed" means the revocation is postponed. Professional practice

may continue so long as the licensee complies with specified probationary terms and conditions, which, in this example, includes 60 days of actual suspension from practice. Violation of any term of probation may result in the revocation that was postponed.

### **"Stipulated Decision or Settlement"**

— A form of plea bargaining. The case is formally negotiated and settled prior to hearing.

**"Surrender"** — To resolve a disciplinary action, the licensee has given up his or her license — subject to acceptance by the Board.

**"Suspension from practice"** — The licensee is prohibited from practicing for a specific period of time.

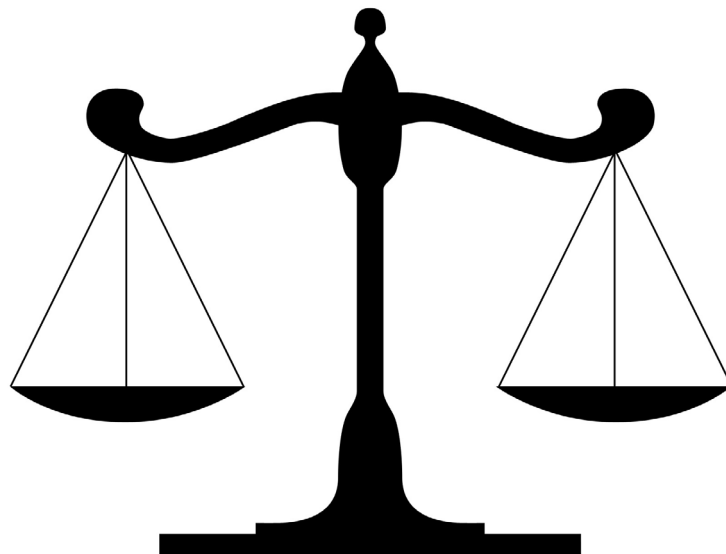
