## Clinical Overview: Fighting HIV with PrEP

Short of abstinence, there is no stronger tool for reducing the risk of HIV than Pre-Exposure Prophylaxis (PrEP). Even though the number of new HIV infections diagnosed annually in California has decreased, there are still close to 5,000 people newly diagnosed statewide with HIV per year, Dr. Philip Peters told the Medical Board of California (Board) during its quarterly Board meeting held on May 10, 2019, in Los Angeles. Peters is the Medical Officer for the California Department of Public Health's Office of AIDS and a volunteer clinical faculty member at the University of California at Davis' Division of Infectious Diseases.

The HIV epidemic in California remains concentrated in men who have sex with men.

Peters' clinical overview of PrEP gave the Board some insight into the powerful drug that keeps HIV infection at bay.

Transmission by male-to-male sexual contact accounted for 67 percent of new HIV diagnoses in 2017. While all racial/ethnic groups have been impacted by HIV, new HIV infections are unevenly distributed, as the rate of new HIV infections in Black/African Americans was 4.3 times the rate among Whites in 2017.

## Let's Talk Consumer Protection

Local forecasters tell us to expect record heat this summer, yet we at the Medical Board of California think we have the “hottest” news.

On July 1, 2019, *The Patient's Right to Know Act of 2018 (SB 1448)* took effect. It requires physicians who have been placed on probation for certain offenses to notify their patients of their probationary statuses. Cases may involve:

- commission of any act of sexual abuse, misconduct, or relations with a patient or client as defined in Business and Professions Code sections 726 or 729;
- drug or alcohol abuse directly resulting in harm to patients or to the extent that such use impairs the ability of the licensee to practice safely;
- criminal convictions involving harm to patient health;
- inappropriate prescribing resulting in harm to patients and a probationary period of five years or more.

This new law helps you make informed decisions about your physicians, and we celebrate this boost in consumer empowerment.

We continue to work diligently with state lawmakers to help craft laws that enhance consumer protection in California. To further our joint efforts, several Board Members and I met with legislators at the state capitol for *2019 Legislative Day*. This provided us with an opportunity to educate legislators with information about the Board and its processes and mission. 

# Steven M. Thompson Award Winner Didn't Initially Want to be a Doctor

Some children examine teddy bears with a stethoscope, dreaming of becoming a doctor. Alan Shih was not one of them. Nothing in his youth pointed to a medical career.

His favorite subject in school was English, particularly when the lesson involved vocabulary and grammar. His favorite activities were sketching, painting, and writing poetry.

"I also enjoyed martial arts for its artistry and emphasis on focus and dedication," he said.

His childhood aspiration: to become an animator for Walt Disney.

Born in Long Island, New York, he grew up in a quiet suburban neighborhood in Southern California. He lived there until attending the University of California Berkeley, where the idea of becoming a physician first germinated and he took pre-med classes "as a hedge," in case his art career didn't catch fire.

"Once it became clear that my future wasn't in the creative arts, I transitioned fairly quickly to taking my MCAT and focusing on med school," he said.

His studies led him to the Chicago Medical School in Illinois. These days, Dr. Shih works as a pediatrician in the Hi-Desert Family Health Clinics in Yucca Valley. His patients range from newborns to 18 year olds.

"I work with quality individuals who comprise the best medical staff in the industry," he said. "We have wonderful families and a strong community out here in the Hi-Desert area."

His favorite things about his job are "the work itself, as well as the individuals I work alongside each day in the office. Everyone cares about our mission ('...to provide affordable quality health care to the communities we serve') and works hard toward that goal. In my opinion, we really provide quality health care to the community. There is something very worthwhile about looking back at the end of each day with a sense of hopefully having made a positive impact on the community and families therein."

By contrast, his least favorite part of his job is dealing with insurance companies.

"It's like a tiny ant trying to move through a thick, viscous ocean of dense molasses," he said.

His advice to young people who would like to become physicians: "Work hard, stay focused and always aim high. And maybe the most important component of aiming high is not to be fearful of failure. Failure is an inevitability on the road to success, especially when the stakes are raised, as is the case in pursuit of a medical degree," Dr. Shih said.

He said he felt fantastic when he learned that he had won a Steven M. Thompson Loan Repayment grant.

"This award takes the worry off my mind and allows me to focus on my patients."





## FDA Warns Of Risks with Insomnia Medications

The Food and Drug Administration (FDA) is requiring a Boxed Warning (its most prominent warning) to the prescribing information of certain insomnia medications because of patient sleep behaviors -- including sleepwalking, sleep driving, and engaging in other activities while not fully awake -- that have resulted in serious injury or death.

These behaviors appear to be more common with eszopiclone (Lunesta), zaleplon (Sonata), and zolpidem (Ambien, Ambien CR, Edluar, Intermezzo, and Zolpimist). For more information, visit the [FDA website](#).

## UC Davis Offers Clinical Strategies to Prevent Firearm-Related Harm

In 2017, an average of 109 people in the U.S. died from firearms every day. Many people injured by firearms have recognizable risk factors, some of which bring them into contact with health care providers before the injury happens.

The University of California at Davis has created [a website](#) offering resources to help providers get comfortable identifying risk and talking about firearms with patients when clinically relevant.

Patient handouts in English and Spanish can be downloaded from the website, as can a video course offered for CME credit.

## Tech Med Corner

### Smart Glasses, Telehealth Instruct Medical Students From Afar

An innovation combining smart glasses and telehealth video conferencing allows a remote physician or student to view exactly what an onsite provider sees, from precisely the same perspective. Smart glasses (made by Vuzix) provide the features and capabilities of a modern smartphone – without a cellular radio – in a hands-free wearable device that resembles an ordinary pair of glasses with a thicker stem on the right side.

Smart glasses have wireless connectivity capabilities. Using such a system could enable students to see exactly what a surgeon is seeing in an operating room. In addition, a remote specialist in a large urban hospital could view exactly what the provider in an isolated rural location is seeing. ### Sober Apps Help Patients

Smartphone apps to help those in recovery can be downloaded from the [DEA's Get Smart about Drugs website](#). All of them are free and available to download on both iPhones and Androids. One example is the Nomo – Sobriety Clocks app created by two people in recovery that “tracks the number of days an individual has been sober. In addition, a person can track the money saved by not buying drugs, share milestones on Twitter and Facebook, and share their sober clock with others. The app also includes exercises to help refocus the person in recovery when he or she is feeling tempted.”

# Medi-Cal Providers Get Medical School Loans Paid Off

On Monday, July 1, 2019, the California Department of Health Care Services (DHCS) and Physicians for a Healthy California announced a commitment to pay off student loans for approximately 240 physicians under a new program created to expand access to care for Medi-Cal patients.

A total of \$340 million has been allocated to the CalHealthCares program from Proposition 56 (tobacco tax) revenue. The recent announcement of awardees is the first of at least five rounds of annual funding.

More than 1,200 health care providers applied for the first round of funding under the [CalHealthCares](#) loan repayment program, which pays up to \$300,000 in debt relief in exchange for maintaining a patient caseload of at least 30 percent Medi-Cal patients, being in good standing with state licensing boards, and other service time obligations. The first round of physician awards total approximately \$58.6 million.

“By removing the burden of student loan debt, this program will encourage more providers to make

different choices when entering the health care market and be able to provide care for the Medi-Cal population,” said DHCS Director Jennifer Kent.

The awards are intended to improve access to care for low-income patients, creating economic incentives for physicians and dentists to provide care to Medi-Cal beneficiaries. Awardees must agree to a patient mix that includes at least 30 percent Medi-Cal patients for five years.

In 2018, SB 849 established the Proposition 56 Medi-Cal Physicians and Dentists Loan Repayment Act Program and appropriated \$220 million for the loan assistance program for recently graduated physicians and dentists. An additional \$120 million was added to the program in Governor Gavin Newsom’s revised 2019-20 budget.

DHCS administers the CalHealthCares program and Physicians for a Healthy California manages the daily operations.

PrEP is a daily combination of two antiretrovirals, tenofovir disoproxil fumarate and emtricitabine, co-formulated as one pill sold under the brand name of Truvada®. PrEP is taken to reduce the risk of HIV infection during a period of risk that could last months or many years. Although other medications are being developed, at present, Truvada® is the only Food and Drug Administration approved drug available for PrEP. A generic version is anticipated to become available in October 2020. If taken as directed, PrEP has been shown to be highly effective in preventing HIV infections.

“It’s almost a straight line correlation between pill adherence and HIV prevention efficacy,” Dr. Peters said.

“This is an area where there are thousands of people who can benefit from PrEP but only a handful of providers.”

For physicians, it can be challenging to identify patients who may benefit from PrEP unless a sexual history is routinely conducted. Due to a large amount of direct-to-consumer advertising, many patients have actually initiated the conversation about PrEP with their doctors. Among people who may benefit from PrEP are those with HIV-positive partners, people with sexual exposures including anal sex, people with a bacterial sexually transmitted infection (STI), and people who inject drugs.

PrEP initiation includes a discussion of potential risks and benefits, obtaining a baseline history, and testing for HIV antigen/antibody and sometimes for HIV RNA, serum creatinine, STI testing, Hepatitis B surface

antigen, Hepatitis C antibody, and a pregnancy test when appropriate.

“The standard of care is increasingly becoming initiating people on the same day that we’re evaluating for PrEP,” Dr. Peters said.

Patients are usually started on a 30-day supply with up to two refills, followed by a monitoring check-in by phone or text to see if they are experiencing side effects, such as nausea, vomiting, or headaches. About 20 percent have side effects, which are usually mild and should resolve within three months. Ongoing

counseling on risk reduction and condom use for STI prevention is important.

- Dr. Philip Peters “The most severe side effect that we monitor for is renal toxicity,” according to Peters.

Patients on PrEP are tested every three months for HIV and STIs (at all sites of exposure). A patient who tests positive for HIV is immediately transitioned into HIV treatment. Patients are also re-evaluated as to whether they have an ongoing need for PrEP. It can be appropriate for people to go on and off their PrEP regimen as circumstances change.

Most insurance plans cover PrEP. In addition, the state of California has an assistance program to help cover medical costs known as PrEP-AP for California residents age 18 or older who are HIV negative and have a modified adjusted gross income of \$62,450 or less for a household of one or \$84,550 for a household of two. Participants must not be

# Medications and Driving: A Guide for Health Care Practitioners

Medications are an important part of our profession, allowing us to improve the quality of our patients' lives by managing diseases and symptoms. Unfortunately, medication side effects can adversely affect driving ability. While physicians are aware of the effects of alcohol on driving and of the grossly-impairing drug classes of medications, such as benzodiazepines, opioids, and somniacs, other less obvious medications include anti-depressants, antihistamines, anti-emetics, and muscle relaxants. Additionally, over-the-counter (OTC) drugs and cannabis may cause psychomotor impairment or have interactions with prescribed agents.

Driving under the influence of drugs is illegal in every state, whether from cannabis, prescription medications, or other substances, and all carry the same consequences as driving under the influence of alcohol. Of the 37,133 crash-fatalities in 2017, almost a third had alcohol involvement; however currently little is known about the contributions of prescription and OTC medications, as well as cannabis, given limited systematic epidemiological methods of data collection. Importantly, estimates of current prevalence indicate approximately 13 percent of drivers are impaired from medication of any source. Additionally, almost two-thirds of drivers over age 50 involved in a motor vehicle crash had received a prescription for a potentially-impairing medication within the previous 60 days.

Physicians have an opportunity and responsibility to mitigate this problem, and there is ample room for improvement: only 18 percent of older adult motorists reported being warned about potentially driver-impairing medications. Physicians can take a proactive approach to reduce medication-related vehicle crashes:

- Encourage patients to bring all drugs, including OTC medications and supplements, to their doctor so they can determine if all are needed and if some may be interfering with the efficacy of others;

- Counsel about medications that can potentially impair driving, including the effects of mixing them with alcohol and cannabis;
- Advise patients to regularly review side effects with pharmacists, including drug-drug interactions; and
- Discuss the use of alternative transportation, such as ride-sharing, to avoid driving impaired. They should plan ahead before consumption, because alcohol, cannabis, and even prescription medications may influence self-perception and decision-making.

The Training, Research and Education for Driving Safety (TREDS) program at the University of California San Diego has developed the Medications and Driving Guide for physicians and other providers. Pocket-guides are available on common medication classes known to impair driving including cannabis. Additional information is available at the TREDS website, or by calling 858-534-8386.

## Free CME from LA Department of Public Health on Understanding Child Care and School Immunization Requirements and Medical Exemptions, Measles Update

California's child care and school immunization requirements changed July 1, 2019 as a result of 2015 legislation.

Parents must now show their child's Immunization Record as proof of immunization in order for a child to start pre-kindergarten (child care), transitional kindergarten, kindergarten through twelfth grade or seventh grade. The law applies to both public and private schools, but not to students being home-schooled who do not attend classes. The only acceptable vaccination exemptions are medical exemptions written by a California licensed physician.

The Los Angeles County Department of Public Health has prepared resources, including [free CME](#), to help health care providers understand and navigate the new requirements.

### Measles Update

As of August 22, 2019, 1,215 confirmed cases of measles in the U.S. have been reported by the Centers for Disease Control (CDC) during the 2019 calendar year. At this writing, on August 26, 2019, the number continues to grow. This is the largest number

of measles cases in the U.S. since 1992. Measles was declared eliminated in the U.S. in 2000.

To date, measles has occurred in 30 states, including California. As of August 15, 66 confirmed measles cases had been reported this year in California.

Physicians are reminded that communicable diseases such as measles must be reported by every health care provider via electronic transmission (including FAX), telephone or mail within one working day of identification. The report must be made to the local health officer for the jurisdiction where the patient resides. The form for making such a report is available from the California Department of Public Health at <https://www.cdph.ca.gov/CDPH%20Document%20Library/ControlledForms/cdph8345.pdf>.

Measles outbreaks continue around the world. Large measles outbreaks are occurring in Israel, Ukraine, and the Philippines. The CDC warns anyone planning to travel internationally to be fully vaccinated at least two weeks before travel. Most measles cases in the U.S. result from international travel, the CDC said.

# Low Income Patients Entitled to A Free Copy of Their Medical Records When Needed in Order to Apply for Benefit Programs

The Medical Board of California has received complaints that some physicians are not providing free medical records to qualifying patients who need the records to apply for certain benefit programs. Providing such a patient's records at no charge is required by [Health and Safety Code section 123110\(d\)](#), which says, "...a patient, former patient, or the personal representative of a patient or former patient, is entitled to a copy, at no charge, of the relevant part of a patient's records, upon presenting to the provider a written request, and proof that the records or supporting forms are needed to support a claim or appeal regarding eligibility for a public benefit program. These programs shall be the Medi-Cal program, the In-Home Supportive Services Program, the California Work Opportunity and Responsibility for Kids (CalWORKs) program, social security disability insurance benefits, Supplemental Security Income/State Supplementary Program for the Aged, Blind and Disabled (SSI/SSP) benefits, federal veterans service-connected compensation and nonservice connected pension disability benefits, and CalFresh."

The patient is not limited to one request, but is entitled to no more than one copy of any relevant portion of his or her record free of charge.

Free copies of medical records are not available to any patient represented by a private attorney (i.e. an attorney not employed by a nonprofit legal services entity) who is paying for the costs of a patient's claim or appeal pending the outcome of that claim or appeal.

## Warning: Hair Restoration Surgery Requires a Medical License

Hair restoration surgery is the practice of medicine in California and may only be performed by properly-trained, licensed physicians and surgeons or licensed allied health care providers authorized to perform such procedures within their scope of practice.


Companies may be marketing surgical devices to physicians indicating that hair restoration surgery is a delegatable procedure, causing confusion about who may use such devices in California.

Physicians may not delegate hair restoration surgery to medical assistants, who are unlicensed individuals with a very limited scope of practice pursuant to [Business and Professions Code sections 2069 and 2070](#) and [Title 16 of the California Code of Regulations section 1366](#). Medical assistants may not perform invasive procedures such as creating

holes or slits in a patient's scalp with a needle, scalpel, or other device.

No unlicensed person may perform these procedures in California, including those using titles such as hair restoration technician, surgical technician, hair restoration assistant, or any other title. California's [Business and Professions Code section 2052](#) prohibits the practice of medicine by unlicensed individuals, as well as aiding and abetting the unlicensed practice of medicine. Violation can result in a fine of up to \$10,000, imprisonment, or imprisonment in county jail for up to a year or both the fine and either imprisonment.



## Workers' Compensation Doctors are Encouraged to Use Free Web-Based Tool

If you are a medical provider involved in California's workers' compensation system, California's Department of Industrial Relations Division of Workers Compensation encourages you to sign up today for free access to a web-based tool at <https://www.mdguidelines.com/mtus>.

Treatment recommendations found in the Medical Treatment Utilization Schedule (MTUS) – American College of Occupational and Environmental Medicine (ACOEM) Guidelines are considered the standard of care to cure or relieve injured workers from the effects of injury ([Labor Code section 4600\(b\)](#)).

Knowing the standard of care and formulating a treatment plan guided by these recommendations will expedite approval of your treatment requests.

Utilization Review and Independent Medical Review physicians are required by law to evaluate requests for authorization against the standard of care established by MTUS-ACOEM Guidelines. Providers who are unfamiliar with the MTUS will not know if their treatment requests comply with these regulatory requirements. Using this tool, providers can quickly find the recommendations that will be used to evaluate their requests for authorization.

# Was Your Prescription Pad Stolen? Do you Suspect Someone is Misusing Your DEA Number? Run a CURES Report!

A [new law](#) (Assembly Bill 2086, Gallagher, Chapter 274, Statutes of 2018) allows physicians to run CURES (Controlled Substance Utilization and Evaluation System) reports for a list of patients for whom that physician is identified as a prescriber of Schedule II, III, and IV controlled substances in the CURES database.

Information contained in the report includes each patient's name, the patient's address, date of birth, and gender. The list will cover the time period of up to one year prior to the date the report is generated.

Such a list is a helpful tool for a physician who may have experienced theft of his or her prescription pad or theft of a DEA (U.S. Drug Enforcement Administration) number. The report will allow a physician to discern if prescriptions have been written with his or her stolen pad or DEA number, and will provide the patient information noted above.

The process for generating a patient list is as follows:

1. Log in to CURES and choose the Patient Activity Report tab.
2. Search Criteria – choose the button for Patient List by DEA#s. Then select your DEA number. Note: physicians prescribing at more than one location have more than one DEA number, so you can choose all your DEA numbers. Then enter the date.
3. Patient List – once users submit the search, the matching patient lists are displayed.

After such a list is created, physicians can go back into the system and run separate CURES reports for each patient on the list, if more information is needed.

If a doctor discovers a prescription in the CURES report that he or she did not prescribe, the physician should contact the pharmacy as well as the [California State Board of Pharmacy](#). fully covered by Medi-Cal or other third-party payers and must be enrolled in a Gilead (manufacturer of Truvada) assistance program if eligible.

Certain parts of the state – for example, the Central Valley, where there are substantial numbers of new HIV diagnoses each year – have very few providers of PrEP, Dr. Peters said.

“This is an area where there are thousands of people who can benefit from PrEP but only a handful of providers,” he said.

Fortunately, providing PrEP is a straightforward medical prevention service that can be implemented in any primary care or specialty practice. PrEP is an exciting method to prevent new HIV infections and working to help more doctors provide PrEP within their communities is a critical step to helping end the HIV epidemic.

# Medical Board of California Seeks Expert Reviewers

If you live in California and have a full-time active practice in California, the Medical Board of California (Board) urges you to apply to be an expert reviewer (expert) for the Board. The Board established its Expert Reviewer Program in July 1994 as an impartial and professional means to support its investigation and enforcement functions. Experts assist the Board by providing reviews and opinions on Board cases and conducting professional competency examinations, medical and psychiatric evaluations.

The Board is currently looking for experts in the following specialties: addiction medicine with added certification in family medicine or internal medicine or psychiatry; colon/rectal surgery; dermatology; family medicine; gastroenterology; neurological surgery; neurology; obstetrics and gynecology; orthopaedic surgery; pathology (preferably from the following counties: Orange, Riverside, Sacramento, San Bernardino, San Diego, San Francisco, and Ventura); pain medicine; pediatric gastroenterology; pediatric surgery; pediatric cardiac surgery; pediatric pulmonology; plastic surgery (with expertise in Neograft hair transplant and gender reassignment); psychiatry (forensic and addiction); radiation oncology; surgery (general and endocrine surgery); thoracic and cardiac surgery; urology (general and gender reassignment); and vascular surgery.

Actively practicing physicians from all other specialties not listed above are also welcome to apply and participate in the program. Physicians must be board certified in one of 24 ABMS specialties (the American Board of Facial Plastic and Reconstructive Surgery, the American Board of Pain Medicine, the American Board of Sleep Medicine, and the American Board of Spine Surgery are also recognized), with a minimum of three years of practice in the specialty area after obtaining board certification; have no current complaints, no prior discipline; hold a current license in good standing and must be willing and available to testify in court.

The Board also needs midwife expert reviewers throughout the state of California. Midwives must be licensed for at least three years in the State of California as a midwife; have an active midwifery practice for the past three years; hold a current California midwife license in good standing; have no prior discipline, no pending accusations, no current complaints or complaints closed within the last three years, and must be willing and available to testify in court. ## New "Therapy Never Includes Sexual Behavior" Brochure Available

Sexual behavior between a therapist and a patient is illegal and unethical. Such unprofessional conduct can be punished by discipline including [revocation or suspension of a license](#), [fines](#) or [imprisonment](#).

It is the therapist's responsibility to keep sexual behavior out of therapy.

A new brochure – "Therapy Never Includes Sexual Behavior" – provides information to consumers regarding client rights, warning signs that the therapeutic relationship may be heading in the wrong direction, common reactions to sexual misconduct by a therapist, what consumers can do, how to file a complaint, where to get help, and answers to frequently asked questions.

[California Business and Professions \(B&P\) Code section 728](#) requires that such a brochure be given to a client by a therapist or the employer of the therapist

who learns from the patient that he or she "...had alleged sexual intercourse or alleged sexual behavior or sexual contact with a previous psychotherapist during the course of a prior treatment..." The therapist or employer is required to discuss the brochure with the patient. Failure to comply constitutes unprofessional conduct.

# What is the best way to see or receive copies of your medical records?

Put your request in writing.

[California Health and Safety Code \(H&S\) section 123110](#) establishes a patient or patient representative's right to see and receive copies of his or her medical records. Physicians must permit the patient to have access to their records after receipt of a written request under H&S section 123110(a). A patient must be permitted to look at the records within five working days of the physician receiving the patient's written request.

Under H&S section 123110(b), a physician must provide an actual copy of a patient's medical records within 15 days of receiving a written request for the copies. Physicians are allowed to charge a fee (not to exceed 25 cents per page or 50 cents for records that are copied from microfilm) plus a reasonable fee for clerical costs. (H&S section 123110(k)).

If you have filed a written request with your physician and you're still having trouble getting the records within the legal time limit, please [file a complaint](#) with the Medical Board of California. The willful violation of the patient's access to his or her health records may constitute unprofessional conduct and grounds for action by the Board.

If a physician moves, retires, or dies, sometimes another physician will either "buy out" or take over his or her practice. The "active" patients are usually notified by mail (as a courtesy), and told where to obtain their records. If you cannot locate the physician, you may want to contact the local county medical society to see if they have any information about the physician's practice (e.g., did someone else take over the practice?).

Additionally, you can contact the Medical Board's Consumer Information Unit at 1-800-633-2322, or go to the [Board's website](#) to Check Up On Your Doctor's License, to obtain the physician's address of record for his or her license. Write to the doctor at that address (even if the doctor's profile indicates he or she is deceased). Request that a copy of your records be sent to you. The doctor has 15 days from the time your letter is received to send you a copy of your records, if the records are still available. If the doctor is deceased or retired, his or her practice may have a plan in place to provide you with your records.

If the doctor died and did not transfer the practice to someone else, you might have to check your local Probate Court to see whether the doctor has an executor for his or her estate. You could then contact the executor to see if you can get a copy of the records. Depending on how much time has passed, whoever is appointed as the custodian of records can have the records confidentially destroyed.

## Questions Received from the Web

Most California-licensed physicians and surgeons must complete a one-time, 12-hour CME course(s) in pain management and the treatment of terminally ill and dying patients. In addition, effective January 1, 2019, this course(s) must also include the subject of the risks of addiction associated with the use of Schedule II drugs. In addition, for those who have not completed this requirement yet, effective January 1, 2019, there are other options available to meet this requirement. The Board's webmaster account received numerous inquiries about the requirement and below are some of the most commonly asked questions.

**I have been licensed for many years. Does this new requirement apply to me?** If you have NOT previously taken the mandatory continuing education course in the subject of pain management and the treatment of terminally ill and dying patients, you MUST complete the required training. If you have already taken the required 12 hours of pain management CME, then you are not required to take additional pain management CME.

**What is the new option available to also meet this requirement?** Effective January 1, 2019, an individual may also meet the 12-hour required course(s) by completing a course on the treatment and management of opiate-dependent patients. This course must include 8 hours of training in buprenorphine treatment or other similar medicinal treatment for opioid use disorders.

**I am newly licensed and haven't completed this course yet. However, I do not prescribe controlled substances. Am I exempt from completing this requirement?** No, all physicians and surgeons EXCEPT radiologists and pathologists must complete the required training, regardless of prescribing practices. For more information, please see Business and Professions Code Sections 2190.5 and 2190.6.

**Where can I find a list of approved pain management CME courses?** The courses or programs must be presented by an organization accredited to provide CME by the Accreditation Council for Continuing Medical Education (ACCME), American Medical Association (AMA), California Medical Association (CMA), or American Academy of Family Physicians (AAFP). In addition to accrediting CME providers, the AMA, CMA, and AAFP may also directly present acceptable programs. Please contact the accredited organizations for a list of approved courses.

**Does the required training for physicians count toward the 50 hours of CME every physician must complete during each biennial renewal cycle?** Yes.

**I believe I already met the pain management CME requirement. How do I check?** To check your records, please call the Board's Consumer Information Unit at 800-633-2322. If staff is unable to confirm records, your information will be forwarded to the Board's CME coordinator for review and response.

## Explanation of disciplinary language and actions

**“Effective date of decision”** — Example: “March 14, 2019” at the bottom of the summary means the date the disciplinary decision goes into operation.

**“Gross negligence”** — An extreme deviation or departure from the standard of care.

**“Incompetence”** — Lack of knowledge or skills in discharging professional obligations.

**“Judicial review pending”** — The disciplinary decision is being challenged through the court system, i.e., Superior Court, Court of Appeal, or State Supreme Court. The discipline is currently in effect.

**“Probationary License”** — A conditional license issued to an applicant with probationary terms and conditions. This is done when cause exists to deny the license application, but limitations can be put in place to protect the public.

**“Public Letter of Reprimand”** — A lesser form of discipline that can be negotiated after or in lieu of the filing of formal charges. The reprimand may include educational and clinical training requirements.

**“Revoked”** — The right to practice is ended due to disciplinary action. The license is invalidated, voided, annulled, or rescinded.

**“Revoked, stayed, 5 years' probation with terms and conditions, including 60 days suspension”** — “Stayed” means the revocation is postponed. Professional practice may continue so long as the licensee complies with specified probationary terms and conditions which, in this example, includes 60 days of actual suspension from practice. Violation of any term of probation may result in the revocation that was postponed.

**“Stipulated Decision or Settlement”** — A form of plea bargaining. The case is formally negotiated and settled prior to hearing.

**“Surrender”** — To resolve a disciplinary action, the licensee has given up his or her license — subject to acceptance by the Board.

**“Suspension from practice”** — The licensee is prohibited from practicing for a specific period of time.


